#### **BUDGET SCRUTINY - EXPLANATION OF PROCEEDINGS**

# **Purpose of the Report**

1. To clarify the purpose of the joint overview and scrutiny budget meeting and how it will run.

# **Background**

- 2. It goes without saying that the annual budget, and therefore the setting of the council tax, is one of the most important decisions which the Council is tasked with making each year.
- 3. The overall aim of this joint meeting is for non-executive councillors to have the opportunity to question the Leader and Cabinet on the content, pressures and rationale of the draft budget before it is put to the full council for agreement.
- 4. Councillors will recall that a similar event took place last year during transition and for a number of previous years in the County Council.
- 5. The Budget & Performance Scrutiny Task Group (of the Management & Resources Select Committee) considered an approach for this year and agreed that the new unitary council should continue with a joint meeting of the select committees which complements Scrutiny's monitoring of the budget throughout the year. This approach is regarded as a model of good practice and Wiltshire has received a number of enquiries from other authorities about its arrangements.
- 6. Rather than create a burdensome and bureaucratic model for the coming together of the four scrutiny select committees, essentially the committees are meeting to consider the draft budget in unison. The first item of business will be for councillors to elect a chairman for the meeting.
- 7. The intentional outcome of this joint meeting is to submit a summary of the views expressed and for these to be taken into account by Council at its meeting on 23 February 2010 when agreeing the 2010/2011 budget.

#### **Evidence and Informed Discussion**

- 8. Councillors will be familiar with the need for any discussion, conclusions and recommendations arising from a scrutiny exercise to be informed and evidence based.
- 9. Consequently, if any councillor wishes to make a proposal on the content of the Cabinet recommendation, s/he should be able to demonstrate credible evidence

- for the proposal. The case for a proposal will need to be strong enough to convince the joint meeting to support such a recommendation, and to stand up to challenge at the Council meeting on the 23 February.
- 10. Equally, councillors will be familiar with the need to focus their questions on strategic and operational matters when considering matters of budget and policy. To assist you in directing your questions at the meeting, a list of the Executive councillor responsibilities is appended to this report.

# **Roles and Responsibilities**

- 11. The Leader of the Council will be invited to present the overall budget recommendation by the Cabinet and to provide the context and rationale for the proposals.
- 12. Councillors will then be given the opportunity to question the Leader based on the evidence presented. She can be supported in answering questions by the Deputy Leader / or Chief Executive.
- 13. Based on the order set out in paragraph 18 below, Cabinet members will be invited to briefly highlight any particular issues associated with their part of the draft budget that they feel would be helpful to the debate.
- 14. Councillors will then be given the opportunity to question the respective Cabinet members based on the evidence presented. He/she can be supported in answering questions by the relevant portfolio holder(s) and / or Corporate / Service Director.

# **Budget Material**

15. Budget reports written for Cabinet's 11 February meeting in preparation for the setting of the 2010/2011 budget have been circulated. Councillors will need to bring their copy with them to the joint meeting. The Cabinet's budget recommendation from the meeting will be circulated as soon as it is available.

#### **Order of Debate & Procedure**

- 16. The meeting will be based on the normal rules of procedure and debate as are set out in the council's constitution.
- 17. In consultation with the chairman and vice chairman of the Overview & Scrutiny Management & Resources Select Committee, the meeting has been structured around the following themes and will proceed according to the approximate timings indicated:
  - 10.45am: the Leader of the Council to present the 2010/11 overall budget recommendation by Cabinet.
  - 11.15am the chairman of the joint committee to invite questions and comments from councillors on the budget recommendation for each department in

the following order:

11.15am: Department of Children and Education

11.40am: Department of Community Services

12.05pm: Department of Neighbourhood and Planning12.30pm: Department of Public Health and Wellbeing

12.55pm: Department of Resources and Chief Executive

1.20pm: Any other strategic and operational matters

1.30pm: the chairman of the joint meeting to summarise the main points, and to

close the meeting.

18. A summary of the comments made at this meeting will be submitted to Council for it to consider on 23 February as part of the budget setting debate.
