9	Partner Updates
	a. Sector Inspector Martin Schorah highlighted key points from the written update from Wiltshire Police. PCSO Sarah Hardwidge was back working in the Neighbourhood Policing Team (NPT) after having her first child. PCSO Andy Willox was also welcomed as a new recruit to the NPT in Calne. Anti social behaviour at The Pippin continued to be a main local issue and to date thirty letters had been sent to the parents/guardians of the young people involved informing them of their child's behaviour. The Police still had this issue as a priority. The NPT had responded to a report of the ATM machine at the Co-op in Calne being tampered with and three males were currently remanded in prison. The Calne Pub Watch Scheme was an ongoing success

	and the Olympic Torch visit to Calne had been a fantastic event. Calne Town Council thanked the team also for their hard work at CalneFest.
	b. Please find a more up to date report, made available since the publication of the agenda pack, from Wiltshire Fire and Rescue Service attached. Mike Franklin commented that in 2011/12 there had not been a fire related death in Calne. Three thousand free home fire safety visits had been made to vulnerable people in the local area. 	c. The written update from NHS Wiltshire was noted.
	d. The Chairman explained there was no update from Calne Community Area Partnership because Trevor Jenkins, former Chairman of the group, had resigned. Malcolm Gull was stepping into the position on a temporary basis, however was unable to attend the meeting due to family circumstances.
	e. There was no update from Calne Community Area Young People's Issues Group as Will Kay, Youth Development Coordinator, was on annual leave.
	f. The Chairman thanked Calne Town Council, Wiltshire Police and all volunteers for helping to make the torch relay a fantastic event. Hilmarton Parish Council had organised a self funded street party to celebrate the Jubilee and raised £600 for community projects. The new pedestrian refuge on the A3102 had been well received. The brewery Arkells was thanked for having their front steps repaired to enhance the look of the crossing area. The Parish Heritage Society had also produced a free Apple ipad application about the history of the parish available from the Apple store. Cherhill Parish Council had held a successful beacon event that had been attended by 120 people. Calne Town Council was involved in many events coming up. These included a town criers competition, a community cycle ride, Calne's first Green Day and the Summer Festival and Carnival on Saturday 30 June.
10	Informal Adult Education in Wiltshire

Consultation would also involve an online questionnaire survey open until 27 June and paper copies of the survey in libraries until 15 June 2012.

Summary of announcement:

The Council is seeking views on the proposals to save money and reduce its carbon footprint by reducing energy usage on street lighting.

The initial consultations is on the proposal to convert about half of the Council's street lighting to operate for part of the night, dim suitable lights when the streets are less busy, and remove lighting no longer required.

Subject to the outcome of this consultation and consideration of the by the Council's Cabinet, the scheme will be worked up in more detail. Further consultations will then be held with the relevant Town and Parish Councils on the individual lights to be changed.

The Council are currently seeking views on these changes to street lighting to reduce energy usage and costs.

Summary of announcement:

The State of the Environment report is the first of its kind for Wiltshire and Swindon, published in May 2012 and funded by NHS Wiltshire and Wiltshire Council. It provides a strategic assessment of Wiltshire's environment and forms the basis of the JSA environment section.

The report gives an overview of facts and figures relating to a wide range of issues, including land use, wildlife, climate change, waste, air quality, water resources and the historic environment. It highlights key themes and trends over time and in relation to the South West and the UK as a whole.

More detailed data is available in a new environment section of the Wiltshire Intelligence Network. This website gives easy access to up-to-date environmental information and online links to a wide range of sources.

The report and website provide an environmental evidence base to inform policy and decisionmaking by local authorities and others, and will help to inform the development of the new Wiltshire and Swindon Local Nature Partnership (a separate briefing on this will be available from August onwards).

Detailed information about the state of the environment in each Community Area can be extracted from these resources. For example, maps are available on the website of environmental designations (such as protected wildlife sites) and agri-environment schemes in each Community Area.

4. Performance and Other Local Issues:

We have decided to continue our patrol strategy from the **Castlefields Priority** due to recieving intelligence of drug use in the area. On Sunday 22nd July 2012 at 19:30 hours, whilst on footpatrols, PCSO's MUSSARD and HARDWIDGE located a 17 year old male at the picnic benches in Castlefields Park. He was found to be in possession of drugs paraphenalia and a quantity of Cannabis. He was arrested and taken to Melksham Custody for questioning. Patrols by the Neighbourhood Policing Team will continue in Castlefields Park to reduce Anti-social behaviour and to reassure other park users that we are being vigilant and taking robust action.

Wiltshire Police - 170 years of public service

Blues and Zuz which is a monthly disco held at the John Bentley School for youths aged eleven to sixteen has proved a success again. In June over a hundred and twenty children attended a 'Olympic' themed disco where top sporting prizes were given away, footballs, cricket sets and scooters. The end of school Bluez n Zuz 'Big Bounce' was held on Friday 20th July where youngsters were able to have fun on a bouncy castle, bungee run, sumo suits and we even hired an ice cream van for them! One hundred and fifty youths attended the event and 13 golden ticket prizes (store vouchers) were handed out to lucky winners.

During July Calne suffered a series of **Night-time Creeper Burglaries** in the Curzon Park bungalows. This has effected elderly residents who were asleep inside their properties when the thefts of handbags and wallets took place. As a result of scientific examinations we have been able to forensically link a male to the scenes. The male has been identified and arrested. He is currently on bail which includes a strict curfew to present himself to police officers on his door step during the night.

Cultivation of Cannabis - On 26th June PC MONAHAN, PC BLAKE and PCSO YATES were conducting a joint visit with Green Square Housing Association at Pym House, The Knapp. Whilst in the building officers smelt cannabis coming from the top floor flat and went to make enquiries. A male answered the door and a search of the property located 42 Cannabis plants and a large amount of Hydroponics. During the search a number of weapons were also seized, knives, smoke grenades, air and gas pistols and a pistol. The male is currently on Bail until 7th August 2012 whilst further enquiries are made. The local Housing Association have begun proceedings to evict the male from the property.

CalneFest took place on Saturday 9th June, this is the second year the event has been held. Eleven uniformed officers (from NPT and Specials) along with a passive drug dog, patrolled the festival on the Recreational Ground, Anchor Road. The operation proved successful as the dog indicated 5 persons to be linked to drugs and it actually detected 2 persons with drugs on them. The three that were searched and found not to be in possession of drugs admitted that had been in contact with drugs the previous day. The team also arrested a young male for Common Assault, he was interviewed and charged with this offence; this enforces that we will not tolerate violent behviour at these events. The operation received a good response from the local people of Calne and contributed to ensuring a safe environment for the festival to take place in.

Further to my previous report, we can update that **Jordan SWEETLOVE** attended North Wilts Magistrates court on 25th July and has been found guilty of the offence 'going equipped to steal' he will now be sentenced on 20th August 2012. In the meantime he will be monitored by electronic tag and he will have to abide by curfew.

Calne Neighbourhood Policing Team has been involved in a **County wide Drugs Operation (OP ATLANTIC)** assisting with executing warrants at addresses in Swindon, Chippenham, Melksham and Calne. The large scale operation took place to target and disrupt the activities and networks of drug dealers across the county. In total 26 people were arrested for a variety of offences including supplying, importing and possessing Class A and B drugs, money laundering and handling stolen goods. In addition, over £25,000 worth of drugs and £6000 on cash were seizes and stolen property including mountain bikes, computer equipment and jewellery were recovered.



August 2012 update

Wiltshire's Clinical Commissioning Group (CCG), the new GP-led commissioning organisation which will be responsible for buying local health services in Wiltshire, continues to develop its commissioning arrangements before it applies for 'authorisation' status in November 2012.

The organisation will take up commissioning leadership from April 2013. The organisation has established its Clinical Governing Board, with 14 voting members (consisting of a Chairman, three GPs who will act as 'locality representatives', an additional three GPs, a registered nurse and a secondary care specialist doctor, one Chief Accountable Officer, one Chief Finance Officer, one practice manager and two lay members) and eight non-voting members: (three 'locality' directors, Wiltshire Council's Director of Social Services, the Director of Public Health for Wiltshire, one member of HealthWatch and two lay members).

The CCG is considering its staffing structure whilst developing those commissioning functions it intends to keep in house. It is estimated that the organisation will have around 70 staff members and it will hold responsibility for managing a budget of approximately £460m to support the commissioning of high quality health services in Wiltshire. Working closely with GPs and other clinicians, the CCG will lead on the development of plans and projects which help meet the NHS's required national savings target of £20 billion.

Wiltshire CCG will take up responsibility for commissioning in 'shadow' form from October 2012, with support from the existing Primary Care Trust staff.

The page overleaf shows an explanatory diagram of how primary health care will be commissioned from April 2013.

JV has responded stating that the programme is reliant upon local volunteers and Calne Without Parish Council has experienced difficulties in identifying local people that are prepared to volunteer. EJ reported that a group has now been formed, which is now undergoing training to carry out the work, however the group consists of the minimum number of volunteers and that if the resident in question would like to join the group they would be very welcome. JV had also informed Sgt Connor and Mr Gray that Sandy Lane has also been included in the SID programme as a response to local concerns about speeds of traffic and that work is planned to build out the junction of Sandy Lane/Back Lane in an attempt to deter the use of the latter as a rat run. JV was asked to let Sgt Connor/Mr Gray know about the opportunity to volunteer to help run the Community Speed watch scheme.

GP reported that Hilmarton currently has the Community Speedwatch equipment and has managed to man the programme with volunteers every day for the last 2 weeks.

3. SID (Speed Indicator Device) rota and new locations

CC reported an email had been received from the Head of Traffic and Network explaining that the SID process is being assessed and reviewed as a result of problems encountered in the process currently being operated. The group felt this was useful as current arrangements have been confusing and the group is still waiting for

7. Other 2012 Priority Issues

- Calne Town Centre Congestion there was a long discussion about the various Area Board working groups that are currently working on Air Quality management; developing a Community Area Campus; involving local people in planning the distribution of funds allocated to safer and less congested routes under a S106 planning agreement. Concern was expressed that without some kind of co-ordination, there is a real danger that the different groups may duplicate or contradict the work of other groups. It was felt that the CATG might step back from undertaking any major projects addressing this issue for the time. But instead should remain aware of the ongoing work of the other groups and, once the air pollution report, the Campus report and the S106 plan are completed, should work towards addressing the gaps rather than working in competition.

8. Issues arising from the Area Board Community Issues System

- 1807/2004 relating to road safety issues at North Street/Lickhill Road. MS advised information suggests that approved development at Lickhill road may be about to start, this may result in the release of monies identified as a unilateral undertaking by the developer to assist in road safety measures in the vicinity. MS said he would get in touch with the planning office to make sure that the CATG group is involved.
- 2398 Quakers Lane/Quakers walk junction Goatacre MC advised that the grass triangle in the middle of the junction is currently being dug out.

9. Other issues:

- Maud Heaths Causeway The Causeway Trust is looking for funding to help repair parts of this scheduled ancient monument that has become eroded in parts as a result of traffic. The planned scheme is likely to be well beyond the means of the Area Board. It was suggested that, if the Trust begins a major fundraising programme in the community, the Area Board might be minded to support it with a community area grant.

Calne Community Area Partnership (CCAP) Claim for Core Funding 2012/2013

1. <u>Purpose of the Report</u>

1.1. To seek the Area Board's approval to core funding to CCAP covering the financial year 2012/13 to be agreed at this meeting, 14 August, 2012 so that it can be paid into CCAP's bank account immediately.

2. <u>Background</u>

- 2.1. Officers are required to provide recommendations in a report, however the decision to support the community partnership and to what level, is made by Wiltshire Councillors on this Area Board.
- 2.2. There will be 2 tranches of funding to community partnerships during 2012/13 (up to 50% of their total projected costs in each tranche). The first is contained within this report, and the Partnership Development Officer will advise CCAP that the second tranche can be requested at an Area Board meeting in early 2013 when evidence is received of how the first tranche has been spent.
- 2.3. Calne Area Board has been allocated a 2012/13 budget of £42,852 for community grants, community partnership core funding and councillor led initiatives.
- 2.4. Community Area Partnerships have been invited to apply for up to 20% of the area board budget. 20% of the Calne Area Board budget 2012/13 is £8,570.

3. <u>Main Considerations</u>

- 3.1. Councillors will need to be satisfied that core costs awarded in the 2012/13 year are made to projects that can realistically proceed within a year of the award being made.
- 3.2. CCAP were awarded £8,465.50 in 2011/2012. The balance of CCAP funds as at March, 2012 was £1,885. CCAP will be rolling forward £935 into 2012/13 to be spent on activities in this coming financial year. This will leave CCAP with a relatively small operational reserve given that they employ an administrator and the financial commitments involved in operating The Hub.

- 3.3. All partnerships funded by Area Boards are required to sign a Community Area Partnership Agreement (CAPA), which will be countersigned by the Chair of the Area Board. The CAPA is to be signed by both parties at this meeting if CCAP's core funding is awarded.
- 3.4. In order to show how the community area partnership aims to meet the commitments set out in the CAPA, CCAP are required to complete a work plan. This work plan has been reviewed and endorsed by Wiltshire Council's Partnership Development Officer as a workable document.
- 3.5. Calne Community Area Partnership submitted a 2012/13 claim for £8,465 total core costs. 50% of this can be considered in the 1st tranche. The area board can therefore award up to £4,233 at this meeting to be paid immediately.

4. Implications

4.1. Environmental Impact of the Proposals

- 4.1.2 The community partnership contributes to the continuance and improvement of cultural, social and community activity and wellbeing in the community area, the extent and specifics of which will be dependent upon individual projects.
- 4.2. Financial Implications
- 4.2.1 Core costs awarded to the community partnership must fall within the Area Boards budget allocated to the Calne Area Board.
- 4.3. Legal Implications
- 4.3.1 There are no specific Legal implications related to this report.
- 4.4. HR Implications
- 4.4.1 There are no specific HR implications related to this report.
- 4.5. Equality and Diversity Implications
- 4.5.1 Community partnerships have agreed to the terms of the Community Area Partnership Agreement, which requires them to be fully inclusive. Membership of CCAP is open to anyone with an interest in the community area.

5. <u>Recommendation</u>

The Partnership Development Officer recommends that the area board:

 approve the whole year's core funding of £8,465 with an agreement to release the 1st tranche of £4,233 immediately agree to the release of the 2nd tranche at an Area Board meeting in early 2013 as long as conditions set by the Partnership Development Officer and agreed by the Board, have been met

	We will attempt to establish Theme Groups, such as Culture

and Housing that are currently inactive.
We will work with the Area Board, the Community Area Manager and WfCAP to promote and firmly position CCAP and the Community Plan within the local decision making process.
We will develop supporting publicity and display material to make CCAP more visible through local level meetings and public events.
We will seek to develop partnership opportunities across the community area and establish closer relationships with established forums and groups.
