



Chairman's Announcements

i. Invitation to comment on proposed Dog Control Orders in Wiltshire

Dog Control Orders can be made by the Council regarding any land to which the public have a right of access:

- 1. Requiring the person in control to clean up after a dog has fouled;
- 2. Prohibiting Access by dogs;
- 3. Requiring dogs to be kept on leads;
- 4. Requiring dogs to be put on a lead when required by an authorised officer of the Council.
- 5. Restricting the number of dogs that can be in the control of one person on certain land.

In exercising its powers, the Authority is required to adopt a fair balance between the needs and aspirations of dog owners and non-dog owners. It is also essential that any orders should be capable of being enforced within reasonable resources.

Currently, there are a variety of inconsistent Orders covering the areas of the four predecessor Districts. It is intended to replace all existing Orders with one consistent set. The proposals are summarised in the table below:

ii. Notice of area board consultation on street trading

Wiltshire Council's Licensing Committee considered a report of the future of street trading at its meeting on 30 November.

Currently there is no harmonised street trading policy for Wiltshire Council, this is due to the former District Councils choosing to control street trading in different ways:

- The North and West areas operate two different consent street trading schemes with different fee structures and different conditions.
- The East operates a prohibited street (trading) scheme for a limited number of streets in the town centres.
- There is no street trading scheme in the South area as Salisbury District Council did not adopt the powers in the 1982 Act.

The Licensing Committee agreed to introduce a new harmonised consent street trading scheme across the Wiltshire Council area. This will provide a flexible means of controlling street trading activity. There is scope for the fees charged for a street trading consent to cover the costs of administration and enforcement. It would also be possible for Wiltshire Council to generate income through the introduction of a new harmonised consent street trading scheme. A consent street trading scheme would allow greater scope for local decision making.

Council officers have produced a draft scheme for formal consultation with external stakeholders (area boards, street traders, members of the public, local businesses, town and parish councils, farmers markets organisation, chambers of commerce and MPs), and invite general comments and feedback. Surveys will be used to ask specific questions on controversial aspects.

Formal consultation with area boards will be taking place in January and February. Due to the priority that Wiltshire Council has attached to the introduction of a new street trading scheme, this project is operating on an accelerated timescale. Therefore, council officers will be unable to attend area boards in person, but will provide an executive summary of the draft scheme and a consultation document accompanied by a complete draft of the scheme.

 - The next CAYPIG meeting would be held on Wednesday 8 December where transport issues were planned to be discussed.

 - Community Safety Group Thanks to the community area grant Melksham were now able to join the Touch2id scheme.
 - Waterways Group The first Consultation exercise is planned for the Melksham link of the Wilts & Berks canal proposals, a questionnaire would be circulated during December, with the next group meeting planned for the 7 December.
 - The Old Peoples Forum Would be holding its next meeting during January 2011, date to be advised.
 - Power Initiative Group Looking at community run energy production.
 - That a CCTV consultant would be looking at the Melksham CCTV system on 2 December to advise on upgrading of the system.

- f. Melksham Town Council
 Cllr Sarah Cardy advised that:
 - The Town Council were pleased with the High Street repaying that had been carried out.
 - Regular showings of movies to be screened at the Assembly Hall, January screenings would include Harry Potter.
 - The Town Council were keen to play their part in the upcoming Melksham campus consultations.
 - Concerns over short term coach parking now that the lorry park had been closed, this problem looked likely to be compounded when Wiltshire Council staff start working from the old George Ward school site and use shuttle coaches into the town centre.
 The Chairman advised that this issue would be looked into once issue sheets had been submitted.
 - Queensway/Sandridge Crossing person had now been lost, as this was a busy road the Town Council would like the crossing person post reinstated. The Chairman advised that this issue is be looked into.
- g. Parish Council Nominated Representatives

- Work was ongoing with the Berryfield allotments.
- Community Flood Planning more information required as to what parishes should be putting in their parish plans.

The Chairman advised that information was available to help parishes complete their flood plans and that the area board had been requesting parishes to return completed flood plans at the last couple of area board meetings.

 The Chairman commended Atworth parish council for their parish plan.

85. Your Local Issues

a. New NHS Medical Practice in Melksham – Dr James Heffer Dr James Heffer advised the area board of a new NHS medical practice that was scheduled to open for the residents of Melksham.

Points made by Dr Heffer included:

- The new practice was the result of the St Damian's medical practice and the merging three of Bradford on Avon medical practices.
- The need to find a new site for the St Damian's practice, it
 was proposed that the new practice would be situated on
 the west side of the river Avon and would house an on-site
 chemist.
- The St Damian's site lease was up in a matter of months and that finding a new site for the practice was a priority, it was hoped that agreement could be reached with NHS Wiltshire for the St Damian's practice to remain on the Melksham hospital site until the new practice was operational.
- The new practice made good sense with the current national situation of funding within the NHS and an ageing UK population.

- The practice would have an NHS spend of £10 million and a drug spend of £2 million.
- The practice would endeavour to keep its patients informed as to developments of the new practice by surgery news letters.

The Chairman thanked Dr Heffer for his update.

b. Conigre Mead Nature Reserve

lan Cardy gave a brief presentation requesting area board support for a proposed lottery bid on behalf of the Conigre Mead Nature Reserve.

Points made by Ian Cardy included:

- The reserve is owned by the Wiltshire Wild Life Trust and managed by volunteers.
- The site is looking rather run down, with work needed on pathways and fences etc.

Decision

• That the Melksham Area Board supports the Conigre Mead Nature Reserve lottery bid.

Points made by Lucy Murray-Brown included:

 Wiltshire Council Cabinet would look at the consultation conclusions at its meeting on the 13 December 2010 and then make a decision. The consultation had shown that the majority of local people wanted a single campus with good access and free parking.

Questions raised from the floor:

 Would a full breakdown of the consultation results be made available?

Yes, after the Cabinet meeting the results and raw data would be made available.

- There seems to be consultation after consultation, when will there be a final outcome?
 - The leisure review would be concluded on the 13 December, the campus in the new year, this item will be discussed at a couple of "campus" themed area board meetings, the area board will then make its recommendations that will be feedback to the Wiltshire Council Cabinet.
- With all services moving onto the campus you will kill the centre of Melksham.

Central government were very keen that local government authorities start co-locating their services, this would perhaps be something that would be looked at as part of the discussions when the full plans were available in February 2011.

Cllr Roy While then spoke on behalf of the Christie Miller indoor bowlers who wished to keep an indoor bowling facility in Melksham and proposed that:

 The Melksham Area Board requests that the Officer team (Wiltshire Council) act on the concerns of the Bowls Club and consider how indoor bowls can be included in the campus proposals currently being drawn up for consideration by the Cabinet and future Board meetings.  - The Area Board would liaise with the Community Area Partnership to sort out a robust consultation process.
- The Town Council and Melksham Without Parish Council would want to be involved in any discussions on the campus project.

Mark Stone, (Transformation Programme Director, Wiltshire Council) advised that all parties were welcome to consult with Wiltshire Council, but that any reports would reflect that the area board was Wiltshire Council's formal consultative body.

88.	Cabinet Member Questions Clir Toby Sturgis, (Wiltshire Council cabinet member for Waste, Property and Environment) gave the meeting an update of current developments within his portfolio. Questions raised from the floor included: • How long will Wiltshire Council be using the George Ward site for? Staff should be based there from January 2011 for around two years. • How are Wiltshire Council doing with "waste to energy"? Currently processing around 50,000 tons. • Waste collection harmonisation — will it happen? Yes, possibly June 2011, but may be later. • Blue Pool site — what is happening? Blue Pool site is owned by Cooper Avon Tyres, detailed work with the land owners needed to be carried out before its future could be mapped out. • Doorstep collections of cardboard and plastics — when is this likely to happen? Timescale dependant on finding a site to separate cardboard and plastics. • Can Wiltshire Council recover methane fro land fill sites? Yes, currently capturing methane at our Compton Bassett site but not economical from some of the older landfill sites. The Chairman thanked Clir Sturgis for his informative update.

2. Comprehensive Spending Review

Work is ongoing to deliver a new policing model to meet the projected funding cuts over the next 4-years. Wiltshire Police Authority is currently consulting with the public, stakeholders and partners about plans to save about £15 million. Mr Macpherson from WPA will be at the meeting to make a short presentation as part of the consultation process.

3. Performance

The reported overall crime figures continue to show that offences in the Community Area are falling. The **16%** reduction is the second best across the county. The number of detections puts Melksham in 3^{rd} place. Full details can be found below in **Table 1**.

NPT officers are still concentrating on reducing ASB in and around King George V Park and have recently introduced a drop-in surgery in partnership with Selwood Housing. The initiative has the support of the Forest Tenants and Residents Association. A key part of this work is to continue to engage with young people to encourage them to join activities run by the Youth Development Service. The Bluz 'n' Zuz initiative continues to be well supported.

There is evidence to support that an increase in reports during December is due to the weather and persons reporting snowballing incidents. Officers have adopted a common-sense approach and have only pursued incidents where there are other factors to suggest an intent to cause harm to another person or property.




Fires by Cause




Non-Fire incidents attended by WFRS




Number of False Alarm Incidents

NHS Update - January 2011

Government announces new vision for public health

The Government's new vision for public health, 'Healthy Lives, Healthy People' was announced by Secretary of State, Andrew Lansley, this afternoon.

'Healthy Lives, Healthy People' also sets out how funding from the overall NHS budget will be ring-fenced for spending on public health in a recognition that prevention is better than cure.

Local government in Wiltshire will take charge of public health from a national budget which could be in the region of £4 billion. Wiltshire Council will continue to work with Corporate Director of Public Health and Wellbeing, Maggie Rae, to provide professional advice and leadership around key challenges like reducing harm from tobacco and alcohol, improving sexual health and ensuring the local population is protected from the impact of major incidents and epidemics such as pandemic flu.

Investors in Carers scheme launched

They provide care for ill, frail or disabled family members worth £511 million a year in the UK, and yet carers often pay a price in terms of jobs, friendships and even health. Carers are twice as likely as others to become ill.

Now a new awards scheme will reward GP practices and others who give special attention to the needs of these unsung heroes and heroines. Aimed at GP practices who do a really good job of taking care of those who care, it awards bronze, silver and gold accreditation as a reward for some of the best practice that exists across the county, as well as acting as a spur to others to do better.

New mums happy with their care

The maternity service provided by Wiltshire Community Health Services has been rated highly by mums in an independent survey commissioned by the Care Quality Commission.

The survey looked at women's experiences of care provided by hospital and community staff, from early pregnancy to four weeks after the birth. Wiltshire Community Health Services provides maternity services at Princess Anne Wing at Bath Royal United Hospital, at the birthing units at Chippenham Hospital and Trowbridge Hospital and at the birthing centres in Frome and Paulton.

The national survey involved responses from over 25,000 women. In Wiltshire, 238 women responded, all of whom had had a live birth between 1st and 28th February 2010 and were aged 16 years or older. Women who had a home birth were also eligible.

Managing flu-like symptoms

The advice issued by Maggie Rae covers how best to protect yourself and your family against cold and flu viruses, how to treat symptoms as they emerge, and how to make best of use of the wide range of NHS services available if you need them, in order to ensure services like 999 and A&E are kept free for emergencies only.

"If you come into contact with droplets, either in the air, on hands, or hard surfaces, you can catch the viruses. Sneeze into tissues and wash hands afterwards. Remember: 'catch it, bin in, kill it'. This advice works for all coughs, cold and flu-like illnesses.

"If you are over 65 years of age, a pregnant woman or under 65 years of age with a chronic medical condition you have not yet had your seasonal flu jab we would encourage you to contact your surgery to make an appointment.

"If you do get symptoms such as cough, fever, aching limbs and weakness, you can manage this at home by drinking plenty of fluids, taking over-the-counter medications containing paracetamol and resting."

Please be mindful to think of other routes to medical treatment rather than calling 999. The following points should be helpful when deciding who to contact.

- Pharmacies offer over-the-counter medicines and advice. As well as being open during regular retail hours, they operate an out-of-hours service on a rota basis
- Call NHS Direct for advice on 0845 46 47 or go to www.nhsdirect.nhs.uk.

 They can give a wide range of advice and information about many conditions
- Use the minor injuries units at Chippenham and Trowbridge for cuts, breaks, burns and other injuries – but not for colds, flu or vomiting
- Make an appointment with your own GP. Your doctor may be happy to give you medical advice over the telephone if you are unable to make an appointment.
- An out-of-hours service is also available if your GP surgery is closed the Wiltshire-wide service 0300 111 5717
- If it is a genuine emergency, go to your local A&E department or call 999 for an ambulance.
- NHS Choices is a website where you can find up-to-date and expert advice on a range of illnesses and complaints, as well as find your nearest NHS services. Visit www.nhs.uk
- NHS Direct provides a confidential telephone service, 24 hours a day, to give professional advice and guidance on health issues, call: 0845 46 47.

Purpose of Report

To ask Councillors to consider 3 applications seeking 2010/2011 Community Area Grant Funding:

- Melksham Tennis Club have applied for a grant of £1095 towards the installation of floodlights on the two all weather courts at Melksham Tennis Club. The recommendation is to award the funding.
- 2. Happy Circle Day Centre have applied for £985 for a series of trips and activities for day centre members (older people living independently). The recommendation is to award the funding.
- 3. **Melksham Town Council** have applied for a grant of £1447 to promote and market the new cinema offering within Melksham Assembly Hall. The recommendation is to award the funding.

1 Report No

1. Background

- Area Boards have authority to approve Area Grants under powers delegated to them by the Deputy Leader and Cabinet member for Community Services (27 February 2010). Under the Scheme of Delegation Area Boards must adhere to the Area Board Grants Guidance for funding.
- 1.2. In accordance with the Scheme of Delegation, any recommendation of an Area Board that is contrary to the funding criteria would need the approval of the Leader, the appropriate Cabinet Member or the Cabinet.
- 1.3. In accordance with the Area Board Grants Guidance officers are required to provide recommendations in their report, however, the decision to support applications and to what level is made by Wiltshire Councillors on this Area Board.
- 1.4. EXAMPLE Two applicants withdrew their applications and hope to reapply at a future date. One application did not meet the funding criteria and was referred to Charities Information Bureau (CIB) for support to seek funding from elsewhere. CIB work on behalf of Wiltshire Council to support community and voluntary groups, town and parish councils to seek funding for community projects and schemes both from the Area Board and other local and national funding sources.
- 1.5. Funding applications will be considered at every other Area Board meeting.
- 1.6. Melksham Area Board has been allocated a 2010/2011 budget of £49,762 for community grants, community partnership core funding and councillor led initiatives. The carry forward from the 2009/2010 budget is £1,783. This leaves a total budget of £51,545 for the 2010/2011 budget.
- 1.7. A decision has been made in 2010/2011 that paper copies of funding applications will no longer appear as part of the agenda in an attempt to reduce volume of paper used. However, the application forms will be available on the Wiltshire Council web site and hard copies available upon request.
- 1.8. The 2010/2011 funding criteria and application forms are available on the council's website (www.wiltshire.gov.uk/areaboards) or paper versions are available from the Community Area Manager.

2. Main Considerations

- 2.1. Councillors will need to be satisfied that grants awarded in the 2010/11 year are made to projects that can realistically proceed within a year of the award being made.
- 2.2. There will be 2 more rounds of funding during 2010/11. The first is contained in this report the remaining will take place on 9 March 2011.

Community Area Grants will contribute to the continuance and/or improvement of cultural, social and community activity and wellbeing in the community area, the extent and specifics of which will be dependent upon the individual project.

- 8.1.1. Planning permission was applied for on 13 Dec 2009. The recommendation is to award the funding subject to planning permission being approved.
- 8.1.2. Application meets grant criteria 2010/11
- 8.1.3. This application demonstrates a link to the Melksham community plan by enhancing sport and leisure in the town.
- 8.1.4. No other locally agreed priorities.
- 8.1.5. The applicant is a non-profit community organisation.
- 8.1.6. The all-weather courts offer a good playing surface throughout the year but cannot be used in semi light or darkness because there is no floodlighting. Although full floodlighting is costly, the Committee has drawn up a plan to put in place adequate lighting in a cost-effective manner. This project will be completed by local traders and use some old light fittings which would otherwise find their way into landfill. When the new lights are in place the Club would offer all year tennis to its members and would hope to increase its membership from the local area.
- 8.1.7. No equality and inclusion issues will be addressed by the project
- 8.1.8. If the area board does not grant sufficient funding the club may be able to allocate a little more money to the project.

- 8.2.1. Recommendation is to award the funding.
- 8.2.2. Application meets grant criteria 2010/11
- 8.2.3. This application demonstrates a link to the Melksham community plan to improve the cultural quality of life of residents in Melksham.

- 8.2.4. Locally agreed priorities: none
- 8.2.5. The applicant is a not for profit organisation.
- 8.2.6. This project is to provide a series of trips/activities to enhance the members' experience at the day centre; and address the issue of social isolation and independence. This programme of activity is an extension to what the day centre would normally be able to provide. Their aim as a charity is to increase and benefit the quality of life of older people living independently in Melksham, and address the issue of social isolation amongst this group. For some a Monday is the members only day 'out', and so trips and carefully planned visits would be special times for these people, which the day centre would not normally be able to afford. Another element of the project is keeping our elderly members fit and active. In doing so the day centre is helping to keep them as independent and active members of their community for as long as possible; helping positivity; and also helping to prevent falls/ recovering gently from illness and regaining strength. Planned activities include: two trips to Rowde for 32 people and 5 sessions of chair based exercises.
- 8.2.7. Equality and inclusion issues addressed by this project: it will benefit isolated older people who are unable to access other leisure/social activities.
- 8.2.8. If the area board does not grant funding the day centre would not be able to run these trips/activities.

- 8.3.1. Recommendation is to award the funding.
- 8.3.2. Application meets grant criteria 2010/11
- 8.3.3. The application demonstrates a link to the Community Plan: the lack of a cinema within the town is specifically referred to as a weakness.
- 8.3.4. Locally agreed priorities: none
- 8.3.6. The applicant is a town council.
- 8.3.7. This project is intended to promote a major new community benefit, alerting residents within the Melksham area to the opportunity to enjoy an affordable high quality cinema experience within the locality. The opportunity now exists through the White Horse Pictures initiative ("WHPI") to bring a cinema facility with cinema quality projection and sound systems to the Melksham Assembly Hall. Melksham is one of a select few locations in Wiltshire and the Test Valley to participate in this initiative which will significantly enhance the leisure and recreational offering within

the town, particularly for young people and families. Crucially, it has the potential to provide a wide community benefit that will serve to encourage people to come together to enjoy a cinematic experience with their friends, families and neighbours. WHPI is being launched as a three year pilot project with a viability review after year one. The grant applied for will allow the project the greatest possible chance of success by advertising and marketing the new offering to the widest possible audience within the locality.

- 8.3.8. Equality and inclusion issues: the project seeks to promote and advertise the availability of a local high quality, affordable cinematic experience for all residents within the Melksham community area, avoiding the costs and travel difficulties associated with a journey to a regional centre or bigger town for a cinema facility.
- 8.3.9. If the area board does not grant funding then the ability to market and promote the new offering will be compromised with a consequential adverse impact on attendances. If the initiative is deemed not to be viable after year one, the WHPI cinema may be withdrawn from Melksham and the benefits it provides for the local community, the town and the Assembly Hall, may be lost.

WILTSHIRE VOLUNTEERS A Bid for PRG Funding - Summary

Amount requested: £55,694

Summary:

The new Wiltshire Infrastructure Support Service – 'GROW' Enhancing Community Support includes a countywide Volunteer Service for Wiltshire for the first time. This application, if approved, would both build on the basic service and develop an accredited volunteer centre for Wiltshire. At present the nearest accredited centre is in Swindon. The proposed service would offer the six core functions of a Volunteer Centre as prescribed by Volunteering England. The benefits to all community areas in Wiltshire will include better access to volunteering opportunities and support to individuals, Employer Volunteering scheme, specialised support, information and good practice services, access to draw down further funding via Volunteering England to support volunteering, and access to support and information as part of a national framework.

What the bid will fund:

- One part time Development Worker post to focus on achieving the six core functions of an
 accredited Volunteer Centre for Wiltshire, at the same time supporting the team to increase
 opportunities for volunteering and supporting organisations to attract volunteers.
- One half-time Development Worker post to develop an Employer Supported Volunteering scheme working with local employers to actively encourage and support staff to volunteer in their community. Promote opportunities and arrange local Community Challenge Events.
- Laptop computer with remote access; mobile phone; display boards; promotional materials; signage; accreditation fees

Outcomes to be delivered:

- Increased volunteering opportunities both formal and informal for potential volunteers
- Increased awareness of volunteering opportunities through promotion and marketing
- Knowledge of Employer Supported Volunteering scheme by local employers
- Successful Community Challenge Events

Additional Information for PRG for Volunteer Centre Wiltshire

Background

The council's Commission for the new VCS Infrastructure Support service includes the 5 Core Functions for an infrastructure support agency, with the addition of training, some additional support for BME groups and critically a volunteering service. Clearly, whilst it is an aspiration of Wiltshire Council to have a fully fledged Volunteer Centre there is insufficient funding to achieve this within the existing resources. This is recognised and acknowledged by the funder and to enable GROW to work towards this it was always understood additional funding would need to be acquired.

Within the GROW team, there are two very part time workers and two volunteers concentrating on providing a basic brokerage service and support for groups to attract volunteers and develop opportunities and advertise. There is no other spare capacity within the team as the commission has other targets to meet.

One way of opening up increased funding opportunities is to enable GROW to gain national accreditation as a Volunteer Centre. To do this there are 6 Core Functions that will need to be evidenced and developed:

- 1. Brokerage
- 2. Marketing volunteering
- 3. Good practice development
- 4. Developing volunteering opportunities
- 5. Policy response and campaigning
- 6. Strategic development of volunteering

Answers to Questions

1. How will the posts and the project be sustained beyond the end of the funding?

To enable GROW to gain the national accreditation there needs to be a dedicated one-off piece of work to build the required evidence and knowledge.. Once this is achieved the day to day work will be maintained by the current (core funded) staff. Becoming an accredited Volunteer Centre will open up opportunities to apply for funding specifically ring fenced for Volunteer Centres. GROW will be working closely in partnership with the Charities Information Bureau to identify funds to support sustainability and continually looking for funding to support volunteering opportunities in the future to build on the accreditation.

2. Are there any baseline figures for the improvement targets given?

DEVELOP only holds limited data around base line figures for North Wiltshire. As there has never been a Wiltshire Volunteer Centre in operation, only district based support through the previous CVSs, it is not possible to provide base line figures.

We have contacted the Economic and Social Research Council-OTS Third Sector Research Centre, who have carried out work on reviewing volunteering statistics but

there is little that is reliable at a local authority level. National surveys like the Citizenship Survey only have a few hundred responses for regions, and therefore any statistics at a County level would not be stable. There is the Places Survey of local authorities, but because of the survey method (postal, not addressed to a specific individual in a household) responses cannot be standardised against other population data so it is not known whether variations between authorities reflect the social mix of the people who live there or not. Also, because of the question used (it asks about "unpaid work" as opposed to "unpaid help") it probably underestimates levels of volunteering.

Building a Volunteer Centre for Wiltshire would give us the hands on ability to start building a picture of the value of the volunteering in Wiltshire.

3. Re. premises costs - Is there an option to utilise existing premises (i.e. perhaps Wiltshire Council)?

The budgets are worked out on a full cost recovery basis and a contribution towards premises is always included in all bids. We will be utilising existing premises and using our outreach offices in Pewsey and Salisbury. DEVELOP would wish to ensure that the local independence of the sector is seen to be maintained and that services are delivered from neutral venues. Furthermore we would not anticipate that use of council premises would be available completely free of charge.

4. What is the Management fee of £7,265 for?

It is proposed to employee two workers dedicated to undertaking and delivering this piece of work. This will require line management, supervision and direction on a one to one basis, managing the budget and reporting to funders ensuring targets are met and employment law is adhered to. Again budgets are worked out on a full cost recovery basis which is recommended and accepted as best practice and forms part of the Wiltshire Council's new Funding Framework for the voluntary and community sector.

Additional Information

Volunteering matters because:

- 1. Essential to the economy (worth £40 billion)
- 2. Essential to individuals providing mental and physical wellbeing
- 3. Essential to public services both internally and working alongside
- 4. Essential to social wellbeing building social capital
- 5. Essential for the future and democratic wellbeing volunteers are more likely to vote and be involved in their community

Volunteering adds value but it is not free and in the current economic crisis volunteers have an important role to play. A Volunteer Centre provides support for organisations and development of volunteering opportunities that enable people to try new things and make a difference to people's lives. Research show that for every £1 invested in volunteering there is a £7-£10 return. 22 million people volunteer equating to £40 billion.

Please describe how your initiative will support the ambition(s) indicated above, and summarise the action that will be taken	The provision of an appropriate additional rail service linking the major towns of Wiltshire (Salisbury - Warminster - Westbury - Trowbridge - Melksham - Chippenham and on to Swindon) would provide a major economic stimulus for the towns along the route, connecting the communities to each other by fast public transport and relieving road pressures, and also providing better links into and out of the area, and through the new proposed LEP region with Swindon up to Gloucester and Cheltenham.
	It has significant support from the business community illustrated by the proactive involvement of Wessex Association of Chambers of Commerce.
	Over the next 3 months, First Great Western are working with the Department for Transport for additional stock and provision of improved services under the current franchise. This provides an important window of opportunity. Wiltshire Council (David Roberts, Dick Tonge, Richard Gamble), First Great Western (Russell Evans), Network Rail (Claire Burch), Duncan Hames (MP for Chippenham and Melksham), Paul Johnson (Wessex Chambers of Commerce / Knorr-Bremse) and

Graham Ellis (TransWilts Community Rail) are working together / feeding through the needed background information to present the complete case, with an estimated start date for the new service in December 2011.

Therefore an investment of £20,000 has the potential to unlock an additional strategic rail service across Wiltshire. We consider through investing the £20,000 as set out there is a very good chance of success and this would lever major additional investment and multiple outcomes for Wiltshire's people, communities and businesses.

Network Rail's Greater Western Route Utilisation strategy (March 2010) gave a benefit to cost ratio for this service (which would not require additional infrastructure) of over 2, and work by Wiltshire Council has also indicated the significant benefits that would accrue from a service running hourly (contact - David Philips). The TransWilts Community Rail Partnership has over 750 signed up supporters via their web site, representing over 150,000 journeys per annum made in Wiltshire, and Wiltshire Council's Local Transport Plan (3), currently in draft form, includes considerable reasoned support for the scheme.

As part of the bid, separate evaluation of the scheme is required through rail industry models (known as MOIRA and LENON) which look at a wide range of data such as previous ticketing experience, passenger flows, comparisions with other areas. These studies / evaluations can only be undertaken by a limited number of organisations with the appropriate knoweldge, and are necessary in order for the case / service to move forward within the Department for Transport System. All indications are that the evaulations will come out favourable, but they cannot be done by voluteers, and an independent specialist consultant will give them the necessary authority, as well as allowing varients on the model to be run to ensure that the best possible proposal for connecting the communities of Wiltshire, and for the area, is the one that is taken forward.

This initiative is in three elements, the last of which is currently being actively progressed with match funding already identified:

- a) Network Rail £5000 Timetabling evaluation
- b) Consultants (probably MVA associates) £15,000

What makes this initiative a local priority (e.g. evidence from research and local support)	Although this bid is being routed via the Melksham Area Board (Melksham would gain more significantly that other towns), it is very much a project that links the larger communities of Wiltshire; if successful it will bring direct public transport, at a significant level, from Trowbridge to Swindon, from Chippenham to Salisbury, and to a host of other journeys which are presently poorly served if at all. Comparative studies and local support; traffic flows and movements along the Trowbridge — Chippenham corridor; much evidence is available. Local support gathered (purely won by unfunded volunteers) from 750 people representing 150,000 annual journeys in Wiltshire and many organisations. Also a strategic priority in the local transport plan, due to both economic and environmental issues.
How will you know you have been successful?	Success will be measured by us gaining an appropriate rail service level as identified by the professional experts, and will be subsequently measured by the numbers of journeys made.
How will you measure the impact? (may have more than one measure)	Numbers of journeys made on the TransWilts Rail line. We will also look for other measures of the effect of those journeys on the local economy, and on factors such as the transfer of traffic to rail from other modes such as private car.
What is your improvement target (s), and when do you expect to achieve this/these?	Currently, there are around 20,000 (est) journeys per annum made by train on the Chippenham via Melksham to Trowbridge. Part of the outcome of the reports that this funding is to sponsor will be to set target levels, but an increase to 80,000 in the first year and to 200,000 within 5 years would be a fair preliminary target.
How will you ensure that the improvement continues after the end of the initiative? (this is one-off funding)	The studies are one-off so no further funding would be needed. The community rail partnership will be seeking limited additional funding from other sponsoring bodies, as with the models on the Heart of Wessex and Three Rivers lines, both of which operate into / through Wiltshire already and have similar key support.

Who will benefit from this initiative?	The benefits will be widespread; businesses in Wiltshire with extra connectivity, individuals who travel from, to and through the communities connected, and the economy of the towns along the way. It should be noted that rail travel (and longer distance connectivity) is especially important for those who cannot drive themselves – young, old, or medically unable to hold a license.

What are the key risks to success and how will these be managed?	There is a strong political will and everyone's coming together as part of this overall scheme, but clearly there's a risk that in spite of all the will and efforts it won't all come through. There's also a small risk that the reports will come out, contrary to all the evidence so far, against a service improvement – but if that's the case, this funding will have been money well spent as it will tell us that we should not be going forward with the requests for a TransWilts rail service as suggested, but rather let the resources it would have used be used for the benefit of others.
