# 9a **Executive response to the task group report**

Cllr Humphries expressed his concerns at the findings presented in the report presented by the Continence Task Group at Health Select Committee on 6 May 2014, and made a verbal commitment to call together the various partners involved in the NHS Continence Services to monitor progress being made towards making the improvements which had been identified. This meeting took time to arrange due to diary commitments of officers in the different organisations involved. Unfortunately having arranged a date and time it had to be cancelled at the last minute due to the ill health of the NHS lead commissioner without whom the meeting would not have been very productive. Officers are in the process of rearranging this meeting and Cllr Humphries intention is to report back to the Committee by the end of July.

# 9b Report back from Task Group meeting with CCG

The Committee endorsed the final report of the Continence Services Task Group at its meeting in May. One of the recommendations was that members of the Task Group would meet with the CCG to present its findings and seek a response from the CCG on the report.

The Task Group met with Dr Steve Rowlands, Debbie Fielding and James Slater from the CCG on 1 July. Cllr Jeff Osborn (chair of the Task Group) will report back on the meeting.
