The Council has adopted the following criteria to determine what item qualifies as a key decision: -

- 1. Any decision which would result in the closure of an amenity or total withdrawal of a service.
- 2. Any restriction of service greater than 5% measured by reference to current expenditure, or hours of availability to public.
- Any action incurring expenditure or producing savings greater than 20% of budget service areas against which the budget is determined by full Council.
- 4. A financial threshold of £500,000 has been set on the basis that this does not include operational expenditure by Corporate Directors that is within the approved budget and the policy framework. (In accordance with the requirements of the new adopted financial regulations adopted 18 May 2010)
- 5. Any area reorganisation plan extending, in effect, beyond a single County Electoral Division insofar as it will impact on the delivery of the service to the public (therefore internal organisational or staffing alterations would not be a "key" decision).
- 6. Any proposal to change the Council's policy framework (documents listed within the Council's Constitution).
