This action will Increase awareness of the club and increasing sustainability by attracting new members. Utilising high quality coaches to increase learning and self improvement of players increasing likelihood of sustained involvement within the sport. On a larger scale it is anticipated that be engaging with our younger members this will provide positive activities for young people and provide alternatives to anti social behaviour that young people may be drawn into and subsequently to encourage development of self esteem, confidence and adoption / maintenance of healthy lifestyles.

We have 3 volunteers who will be attending level1 coaching couses in April 2010 & will be coaching the younger age groups on a Monday night. It is felt that the older youth members (under 17) would benefit from specialist training from a fully qualified local adult coach. It should be noted that Chippenham CC have limited capacity and therefore Westinghouse is providing an oportunity to get involved and develop cricketing skills for members of the community who would otherwise miss-out.
