How did you discover there was a need for your project and how will your project benefit your local community?

There is evidence, anecdotal and surveyed with regard to Domestic Abuse (DA), e.g. in the Joint Strategic Needs Assessment (JSNA) for this community area. This area is ranked 5th worst out of the other 20 community areas, Trowbridge, Salisbury, Chippenham and Devizes being in the worst 4. Based on the projected volume of female residents (16-59yrs) in this area, of 8,670 we are able to project the likely expected volume of DA incidents based on regional data from the British Crime Survey. The estimate for an area of this size would be 572 in 2009/10.

Re. Last Orders – there is evidence from hospital admissions for alcohol related conditions in the JSNA. This area is ranked 24/62 in calculations estimating the prevalence of binge drinking in Wiltshire. The Police report that 21 alcohol related incidents occurred in this area between April and November 2010, ranking 5th worst in Wiltshire – and as above, this area, follows Trowbridge, Salisbury, Chippenham and Devizes.

## Any other information about your project.

Although the Amesbury & Durrington Area Multi-Agency Forum (ADAMAF) has only met 4 times, DA is evident in 80% of the cases it has reviewed. 15 schools and 19 agencies/services are involved in ADAMAF. 65% of local Parent Support Advisers service workload is supporting families experiencing challenges due to family relationship and/or substance abuse.

The Stonehenge School has analysed its attendance data with Education Welfare Service data, and DA was evident between 7-16% of families whose children had low attendance, needing targeted support. DA is a hidden crime, so the actual figures maybe higher
