Catchment Sensitive Farming (CSF) raises awareness of diffuse pollution from agriculture by giving free training and advice to farmers in selected areas in England. The aim of the advice is to improve the environmental performance of farms.

Advice is only available in high priority areas for water quality. These areas will contribute most to meeting Water Framework Directive objectives. To find priority areas and local data on MAGIC (http://www.magic.gov.uk/MagicMap.aspx):

- select 'Countryside Stewardship Targeting & Scoring Layers', then 'Water', then 'Countryside Stewardship Water Quality Priority Areas (England)' in the Table of Contents
- · enter place or postcode in 'Map search'
- · use the 'Identify' tool under 'Feature Tools' to get local data

CSF is a project run by Natural England in partnership with the Environment Agency and the Department for Environment, Food and Rural Affairs. It's staffed by trained, qualified and experienced advisors. The advice is confidential and not disclosed to other parties.

CSF complies with Article 22 of Commission Regulation (EU) No 702/2014 on how it gives advice. The amount of aid given for advisory services is limited to 1,500 euros per farmer per advisory theme.

# **Countryside Stewardship**

CSF supports farmers applying for Countryside Stewardship to improve water quality and biodiversity and to reduce flood risk. Funding to improve water quality is now available through the Countryside Stewardship Mid Tier application process. See the Mid Tier page (https://www.gov.uk/government/publications/countryside-stewardship-mid-tier-including-water-quality-capital-items-manual) for more information.

Some Countryside Stewardship capital items require written support from a Catchment Sensitive Farming officer (CSFO) as part of an application's evidence requirement. Check the capital item requirements for Mid Tier (https://www.gov.uk/government/publications/countryside-stewardship-mid-tier-including-water-quality-capital-items-manual) to find out when this is necessary.

Endorsement of a Mid Tier application by a CSFO will increase the chance of success for holdings targeted for water quality outcomes. Applicants who require this support should contact CSF and arrange a pre-application visit.

# Training and advice

All CSF training and advice aims to give practical and cost-effective solutions to improve water quality through:

- workshops
- demonstrations
- · farm walks
- · farm events
- one-to-one advice on solutions from groundwater protection to whole farm appraisals

You need to be in one of the high priority areas for water quality to qualify for training and advice. Contact your Catchment Sensitive Farming officer
