Proposed Changes to the Wiltshire Core Strategy Policy Maps

This document illustrates the changes required to be made to the adopted Wiltshire Core Strategy (WCS) Policy Maps¹, following the adoption of the Wiltshire Housing Site Allocations Plan (WHSAP). This document should be read in conjunction with the Wiltshire Housing Site Allocations Plan Submission Version (July 2018), and the Schedule of Proposed Changes (July 2018).

The changes that are illustrated on the following reproductions of the community area level WCS Policy Maps relate solely to (i) the location of new housing site allocations, and (ii) settlement boundaries that have been reviewed by the WHSAP or through a sufficiently advanced² or Made Neighbourhood Plan.

New housing allocations proposed by the WHSAP are depicted in yellow and are individually labelled with the site's unique reference number and site name. These occur at the following locations:

- Ludgershall (refer to Tidworth Community Area Policy Map)
- Trowbridge (refer to Bradford on Avon, Melksham, Trowbridge and Westbury Community Areas Policy Map)
- Warminster (refer to Warminster Community Area Policy Map)
- Chapmanslade (refer to Warminster Community Area Policy Map)
- Hullavington (refer to Calne, Chippenham and Corsham Community Areas Policy Map)
- Yatton Keynell (refer to Calne, Chippenham and Corsham Community Areas Policy Map)
- Bratton (refer to Bradford on Avon, Melksham, Trowbridge and Westbury Community Areas Policy Map)
- Salisbury (refer to Salisbury and Southern Wiltshire Community Areas Policy Map)
- Durrington (refer to Amesbury Community Area Policy Map)

Settlement boundaries of Principal Settlements, Market Towns, Local Service Centres and Large Villages that have been reviewed by the WHSAP are depicted by a black line boundary. These appear on all the Community Area Policy Maps that are set out below.

For spatial context, but not as a result of the WHSAP, the policy maps also show the settlements where a settlement boundary review has been carried out either by a sufficiently advanced or Made Neighbourhood Plan, or the Chippenham Site Allocations Plan; and the location of Small Villages within each of the Community Areas. The settlement boundary for Chippenham is depicted by a brown line boundary. Settlement boundaries that have been reviewed by a Neighbourhood Plan are depicted by a purple line boundary. Small Villages are broadly indicated by a red dot.

Following adoption of the WHSAP, the community area level WCS Policy Maps will be updated to incorporate the additional housing site allocations, and to update the settlement boundaries that have been reviewed by the WHSAP or a Neighbourhood Plan. Equivalent updates to the adopted WCS inset maps³ are not shown in this document, but will also be made following adoption of the WHSAP.
