# Points of interest arising from decisions

### W/09/01934/FUL - 14 Albany Close Trowbridge

The Inspector appreciated that front extensions are not always appropriate but he took the view that the dwelling was situated within a large garden and there was no established building line and as such there would be no harm. Furthermore, he did not share the Council's view that there would be any harm to neighbouring amenity resulting from the proposed rear extension or that a proposed shed within the garden would have a harmful impact on visual amenity.

The Appellant made an application for costs against the Council. This has been robustly defended and a decision on whether or not an award of costs will be made is still pending.

#### W/09/01648/FUL - Little Bowerhill Farm 457 Bowerhill Lane Bowerhill

The Inspector in allowing this appeal agreed with the Council that certain elements of the proposed alterations would diminish the character of this historic rural building. However, since the farmhouse was not listed and not within a designated conservation area or area of outstanding natural beauty and other aspects of the scheme would enhance the built form he considered on balance that the positive aspects of the proposal outweighed the harm that would be incurred.
