How did you discover there was a need for your project (please provide evidence) and how will your project benefit your local community? Amesbury is currently suffering an economic downturn, with footfall in the town centre affected by the nationwide economic climate, roadworks, and out-of-town competition and recent parking charges. The proximity of Stonehenge – which sits within the parish boundaries – shouldn't be ignored, and is recognised as a missed opportunity to tell visitors to come to Amesbury /Salisbury/Wilton for a day out experience rather than other Towns out of the area. From evidence gathered at Stonehenge, tour operators don't visit because they are unaware of Amesbury's attractions, what to do or where to go. With no Brown and White signs Historic Amesbury is also missed by car driven tourists, who simply don't know it exists. Amesbury is steeped in History and its local heritage, captured through art and cultural activities if marketed & developed can be used to draw visitors into the town. Local businesses will obviously benefit from this. The community-centred Amesbury 2012 programme, inspired by the Olympics, will also be focus on the heritage and used to showcase Amesbury, boost community spirit and also bring local people into the town.

The Town Council has the power to raise local taxes to fund the project, and it is putting £2,000 towards it. With the current economic climate, and following the lead of Wiltshire Council, the precept was maintained to ensure no rise in council tax for the residents of Amesbury.

This is not a one-off project, but rather the beginning of a long-term project, which extends far beyond 2012 and the Town Council will continue to promote the town.

Once people participate in sport, they are very likely to continue with the activity.

As more businesses come to the town, so will more people visit. The busier the town, the more attractive it is to businesses....

A new community group will be formed to look at/promote future community events.
