The Festival encourages parishioners of all ages and gender to work together towards a common goal and engenders pride in their community and local area. The Festivals are the biggest activities in the Aldbourne area and foster an excellent community spirit, thereby benefitting all who live within the parish and surrounding areas. The Aldbourne festival takes place every 10 years and each is themed to a different area of history. The Civil War period theme has been chosen because Aldbourne played a part in the Civil War as Charles visited the area and a battle was fought just outside the village. There is documentary evidence that a munitions cart was exploded in the village. The hands of the Goddard Monument in the Church were broken off and a Cromwellian helmet and sword sit high in the roof area above the monument. It is intended that these events and others will provide part of a tablo during the weekend. There is a talk being given on Aldbourne's part in the Civil War, on the Saturday. The school has already been involved in articles for the programme and it is intended that enactors will visit the school prior to the weekend. It is a very relevant era to the village. It would be very hard to do this without the help of a reenactment group, who unfortunately have to charge us, so hopefully you will see fit to award this grant. It will be a spectacle that the whole village and surrounding area should benefit from.
