The Newton Toney Parish plan was published in 2009; it criticised the lack of team sporting facilities and the lack of equipment for teenagers. On the village recreation field, there are cricket nets, 5-a-side goals, balancing apparatus (parallel bars etc), a basketball hoop/net with backboard assembly and a play area for the under 12s. The basketball facility is not used as there is only grass surrounding, which is not suitable. The Parish Council and the Hall Committee (which is responsible for the recreational facilities) have been approached by villagers requesting the provision of a hard-standing for the basketball/netball practic area. The addition fo this hard surface will benefit the young and older members of the community as it will provide not only a 'fun' sporting facility but an area on which a 'shortened' game can be played. New, mobile netball stands are available which can be placed on the hard standing. Thus, the facility will be suitable for all.

The Memorial Hall committee is responsible to the Parish Council for the upkeep and maintenance of the recreational facilities. The committee has funds (gained from community functions and donations) which are available for the upkeep of the Hall and recreational facilities. It is not anticipated that repairs to the hard standing will be required in the next 10 years. However, replacement of nets and balls will be purchased on an 'as required' basis.

The local primary school and older children in the village will benefit from the basket/netball facility. In addition, the facility will be available to all other age groups. A secondary school teacher, living in the village, has expressed an interest in coaching and running basketball games. There are no barriers proposed for the usage of of the proposed facility; it would be there for everyone. Success will be demonstrated by the overall use of the facility. Balls will be easy-access and will be provided by the Hall Committee. As an addition, the 8m by 6m solid base may be used for other activities, including skateboarding, a pre-school playing area and the Annual Fete.
