Important: Please do not type/write in paragraphs – This section is limited to 1000 characters only (inclusive of spaces)	Domestic violence accounts for between 27% of all violent crime in Wiltshire. 50 % of all cases referred to Wiltsire Council Families and Chidlren are attributable to domestic violence (Wiltshire Domestic Abuse Strategy 2009-2011). Salisbury ranks 18th out of 20th in the JSNA. Domestic violence has been identified as a priority area in the Wiltshire Community Safety Partnership Strategic Assessments Sept.2010. We have regular referrals from Health Visitors, Social care and schools who have identified women and children who are severely affected by DV. We have a close partnership with Salisbury refuge and offer women a change to make positive and long lasting changes to their and their children's life.			
	Each new group receives between 12 and 16 referrals.
