We will pay for their lunch and travel expenses. They will work alongside existing staff loading the van, delivering goods and managing the warehouse.

Unemployment in the constituency is still on the increase. Since January 2011 unemployment in the constituency has risen 24.3 per cent. This gives Devizes the sixth worst percentage increase of all the constituencies in the United Kingdom. One of the strategic priorities of the Devizes Strategy and Action Plan is to create more employment opportunities to the area and to encourage community involvement and volunteering, especially among young people. Many of our clients, who are often from disadvantaged families in Kennet, enquire about volunteer and training opportunities within the Furniture Project. People's confidence and self-esteem will rise and they will become more involved in their communities as a result.
