In the most recent Crime and Disorder Audit (2004), Amesbury West featured as the highest rated ward in Salisbury District for domestic violence (DV). In Stonehenge School, there has been a high level of school absence: investigations by the Educational Welfare Officer found that a very high proportion of those children absent had witnessed or been exposed to DV. Splitz has therefore been working with the school for some time and is concerned by the attitudes of some of the children toward DV. By addressing these, the project will lead to healthier relationships and a healthier community.
