1. Safeguarding Children & Young People Task Group

Since the Committee's last meeting, the Task Group has met with:

- The Head of Referral and Assessment Children's Social Care
- Assistant Team Managers (ATMs) from the Referral & Assessment team
- Child Protection Chairs (CPCs) and Independent Reviewing Officers (IRO) from the social care team
- Head of Service Integrated Youth

Attending Multi Agency Forums

Several members attended Chippenham MAF in order to learn about MAFs' operation and discuss attendees' views of safeguarding in Wiltshire. The Task Group now plans to attend MAFs in other community areas.

Visits to other local authorities

On 12 October the Task Group visited Swindon Borough Council, which received an Ofsted grading of 'Good' at their last safeguarding inspection. The Task Group met officers from social care and Swindon's Lead Member for Children's Services. Learning points from the visit included:

• Swindon's social care teams have low staff turnover, stable management and a low number of temporary staff.

- Staff across the different agencies value having established and stable networks of contacts.
- The social workers consider themselves to be effective at managing the anxiety of other agencies – they consider this a key part of the job. A 'Lead for School Safeguarding' post has helped to reduce the number of unnecessary referrals.
- Swindon's children's services scrutiny committee receives a safeguarding performance report at every meeting.

A visit to Dorset County Council is now being arranged.

Future work

Following its formation, the Task Group resolved to focus on four key themes:

- 1. Communications
- 2. Workloads
- 3. Locality working
- 4. Future scrutiny of safeguarding

The Task Group plans to cover areas 1 to 3 up until Christmas 2012. Members believe this will give them a good enough understanding of safeguarding issues to effectively undertake area no. 4. The Task Group will meet on 29 November to review progress and agree what further work is required.

The Task Group then plans to bring its final report to the Children's Select Committee on 28 March 2013.
