Where this Licence authorises the supply of alcohol-

- 1. No supply of alcohol may be made under this Licenco:
- a. At a time when there is no Designated Premise's Supervisor in respect of it
- b. At a time when the Designated Premises Supervisor does not hold a Personal Licence.
- 2. Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a Fersonal Licence.

Irresponsible Promotions (On Sales Only)

- 3. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not part out, arrange or participate in any irresponsible promotions in relation to the premises.
- 3. (2) In this paragraph, an irres, onsible promotion means any one or more of the following activities, or a botto ntially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, rejudice to public safety, public nuisance, or harm to children—
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:
- (d) provision of free or discounted alcourt in relation to the vie ving on the premises of a sporting event, where the provision is dependent on—
- (i) the outcome of a race, competition of other ever t or process, or
- (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encounage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

Dispensing Alcohol Directly into the Mouth (On Sales Only)

4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than when that other person is unable to drink without assistance by reason of a disability).

Free Tap Water (On Sales Only)

5. The responsible person shall ensure that free ter water is provided on request to customers where it is reasonably available.

Age Verification Policy

- 6. (1) The premises licence holder or club of entires certificate holder shall ensure that an age verification policy applies to the promises in relation to the sale or supply of alcohol.
- 6. (2) The policy must require individuals who appear to the responsible person to be under 18 years of ace (cr such older ace as may be specified in the policy) to produce on request sectore being served alcohol, identification bearing their photograph, date of both and a holographic mark.

Drink Volume Measures (Or. Sales Only)

- 7. The responsible person small ensure that-
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the pemises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

Door Supervision

Conditions attached after a hearing by 'he 'icensing authority

- 1) That an additional CCTV camera is installed at the club premises oriented along Lover Sourt.
- 2) The conditions agreed to be added to the operating schedule, pursuant to the licensing objectives and namely:

- i. A noise limiting device shall be fitted on the first floor and all live music provided on this floor shall be played through this device. The noise limiter shall be connected to the mains supply and prior to any live music being provided, the imiter shall be set at a level agreed with officers from the Environmental Protection Department of Wiltshire Council. This level shall not be altered and once agreed, access to the limiter shall be restricted to senior members of staff only for resetting purposes;
- ii. The applicant shall submit a most management plan. The plan shall include a suitable most or ng regime when live music is being provided on the first floor, including exact locations, frequency and docume, any evidence that monitoring is being carried out. The plan shall be carried by the Council's Environmental Projection Department in writing before any regulated entertail mean takes place at the premises. Any minor alterations to the colse management plan shall be submitted to and agreed in writing, by the Council;
- iii. Live music on the first floor shall be limited to two events per caler ar nonth; and
- iv. Live music on the first floor shall cease at 23.30 hours.

Conditions consistent with the operating schedule

- 1. A CCTV system with recording capability is installed to cover all cors of the premises used under the terms of the Licence and shall also cover all entrances, exits and external areas immediately around entrances. The images produced shall be of sufficient quality so as to enable identification. Images to be retained for a minimum of 30 days and be made readily available to any authorised Officer of the Council or Police Officer on duty.
- 2. For special events, including New Years Eve, SIA s curn / staff will be employed at the premises.
- 3. Staff will be trained in the law and practice of the libensing (act and other relevant legislation.
- 4. Proof of age will be required from any person reeking to purchase or consume alcohol who appears to be under the age of 25. This evidence shall be photographic, such as a passport or photographic driving libence. Touch 2ID is also installed and operates at the premises.
- All staff hold a current CRB check
- 6. Staff are trained in first aid.
- 7. When licensable activities are taking place, the exterior of the premises are to be well illuminated during hours of darkness.
- 8. A nominated member of taff will monitor sound systems and attention will be paid to noise levels from, music, u e car park and people entering and leaving the premises.

9. Recorded and up to date health & safety and fire safety risks assessments have been carried out for the premises.
