All local primary schools hold summer and winter concerts also used for lectures, recitals, musical events, garden of remembrance for Royal British Legion, RAFA Annual service. Flower Festival, heritage open days (with tours), and used by U3A, Camera Club, cancer research, fair trade, Rotary 'Tree of lights'. Increasing use indicates that the Chapel is making a difference.
