6. Project summary:

A community orchard on Steeple Langford Allotments, as part of a new thrust in the village to renovate the allotments, encouraging greater community involvement and local food production. Thirty apple, pear and plum trees, using traditional varieties, will be planted on

0.5 hectares on the lower slopes of the allotments, this autumn. Half or full-standard size trees, with fertiliser, stakes and ties, mulch mats and livestock guards will be used. Voluntary wardens will carry out on-going maintenance, including watering, weeding and pruning. The orchard will be laid out with mown paths and a wooden bench to provide a facility for all.

Local people in the Parish will benefit from the community orchard, which will be a green space, open to all, with mown paths and a wooden bench, within Steeple Langford Allotments. Some of the fruit trees will be commemorative, creating a place of tranquility and retreat. The orchard will be used for occasional events such as Apple Days and barbecues; and be available as a training and activity resource for the local school and Youth Club. Wildlife will benefit – traditional orchards are a priority habitat in the UK Biodiversity Action Plan. The Steeple Langford Allotment Trustees and other local people will be actively involved in the planting of the orchard, on-going maintenance and, after five years, harvesting and distributing the fruit. Skills will be gained in tree care e.g. pruning. A central aim of the Steeple Langford Allotment Trustees is to help the “needy”™ in the Parish, which can be achieved through generating income and passing this on as small grants, from the sale of fruit at pick-your-own days or a village stall.

14. How will you monitor this?

The Steeple Langford Allotment Trustees provide an annual report to the Parish Council. A new bank account has been set up and accounts are being kept.

15. If your project will continue after the Wiltshire Council funding runs out, how will you continue to fund it?

It is not anticipated that any further significant expenditure will be needed once the orchard is established. On-going maintenance will be provided by volunteers.

1567 pupils on roll in the cluster of 7 schools in Amesbury and surrounding area will benefit from this project. A recent evaluation shows that out of the 35 children seen for counselling, at one primary school over the past year, 42% have an MOD connection. Several children have had to cope with bereavement and family deployment. The counselling has provided emotional support thus creating a positive environment to facilitate strategies for both teaching and learning. All the schools are aware of the rising needs of young people to help with mental health issues, dysfunctional family problems, domestic violence and abuse

whilst other available services are decreasing. Young people who have used the existing counselling service have said: 'they have enjoyed the counselling and having someone that they can talk to.' 'That it has been useful to be able to talk to an impartial person about their feelings.' 'That they feel a lot happier now.' 'Young people get depressed. Instead of talking to a teacher it is easier to talk to someone you can trust.' 'If you are upset at school you aren't going to tell anyone. It is possible to tell the counsellor.' 'Counselling may make people more confident. I like going to see an adult professional counsellor who I can trust.' The existing project runs for 3 days a week across the 7 schools in the cluster and ends 31st July 2013. We are seeking funding to extend the project as the needs of young people has increased in all 7 schools.

From evaluation of the counselling service on an annual basis. Previous evaluations show that counselling has improved things at: Home by 81.5%; School by 75% and generally 94.5%. 100% of young people who received a counselling session said they would recommend it. Young people in the community will be able to access a professional service within their own local school. This will be monitored by head teachers and governors in each school.

The children's groups and the families in the village will have a wonderful facility for focussed play to aid in learning. This facility contributes to overall village harmony in that it is designed for a wide range of ages and offers opportunity for people to meet in a relaxed setting.

The Langfords Recreational General Management Group (LRGMT) manage the play park on behalf of the SLPC. The SLPC is well represented on their Boar, co-operation is well established and therefore it is easy to identify benefits and issues as they arise.

The purchase of safe and modern equipment should enable this facility to exist for many years to come. If ultimately there is no Council support, the costs will have to be raised out of increased local taxation, grants from other bodies or potentially corporate sponsors.

We are requesting Â£3075 match funding, because this is the amount the SLPC can match at this time. The total cost of refurbishment of the play park is Â£11012. Further funding will have to be discussed.
