The small reserves are the only funds the committee has available for maintaining the village hall and the Memorial Playing Field. Rebuilt in 1982, the village hall requires constant upkeep and maintenance. The Memorial Playing field site is also managed by the same committee and equally needs a reserve for maintenance. A reserve for any unforeseen costs that may arise on either site is vital eg felling of a memorial tree if necessary, loss of major rental income if a high user has to close.

The replacement table project will benefit all users of Great Bedwyn Village hall. This includes villagers who hire the building for social uses - weddings, parties, jumble sales etc but mainly the many villagers who participate in the various clubs and activities that happen daily at the hall. Great Bedwyn Village hall is now the only venue with large hall space in the village (pop. 1200) due to the closure of the British Legion building in May. This means that we need to maximise storage in the hall to make way for new users who have moved from the Legion eg Bedwyn Youth Group, and ensure that the hall and it's facilities are as attractive as possible. This will maximise rental revenue and thus ensure the longevity of the hall which is

so important to so many groups in the village. Great Bedwyn Village Hall and Memorial Playing Fields committee is made up of a representative from each group who uses the hall or playing fields as well as 'Village Reps'. The groups include, Great Bedwyn Scout Group, Great Bedwyn Youth Group, Great Bedwyn Cricket club, St Mary's Church, Great Bedwyn, Great Bedwyn WI, Great Bedwyn Tennis Club, Great Bedwyn Music Society and Great Bedwyn Playgroup and Toddlers With the closure of the legion we are also expecting new members from other village groups such as the Great Bedwyn History Society. Great Bedwyn Parish Council, as monthly users of the hall, also have a representative on the Village Hall committee. Replacing the older tables which are difficult to store and handle will improve facilities further following the recent purchase of new seating storage and chairs.

We will be in regular contact with the main users of the hall as each affiliated organisation is represented on the Village Hall and Memorial Playing Fields committee. We will seek feedback through these members. We will be able to monitor how the tables are taken out, used and put away and how to continue to provide better storage solutions for the main users of the hall.

The maintenance of the village hall is carried out by the Village Hall and Memorial Playing Fields committee. The condition of the hall and all contents, how they are stored, stacked and moved around will be monitored carefully and any maintenance needed will be undertaken by the the committee. This is funded entirely through rental of the Village Hall.

The Wharf at Great Bedwyn is a meeting place and an important junction that links road, the canal and rail. It is well used by visitors and locals alike, whether it is ramblers starting a walk at the map on the plaque or canal boat users. The area is popular with fishermen, holiday makers and is also the location of the Brust Trust who provide exciting boat trips for the disabled. The Devizes to Westminster boat race is an important date in the village calendar. The community as a whole would benefit from an improvement in the appearance of the Wharf. Planting trees will greatly enhance the area, and serve to give it definition as well as promote a sense of identity. It will be more likely to become a destination rather than a passing place. The PC anticipates a picnic area could be introduced and events can to be planned as a result.
