<b>Project Title/Name</b>	No Cold Calling Zone		
<b>Please tell us about the project /activity you want to organise/deliver and why?</b>	<p><i>The introduction of a Pilot No Cold Calling Zone to deter doorstep crime. This is a proven method to reduce doorstep crime, particularly against the elderly and vulnerable. Residents will be consulted about the scheme, given information about how it works and how to react to cold callers. Residents will report cold callers who ignore the signs. Partnership working between the Police and Trading Standards over the past ten years has significantly reduced doorstep crime and detection has improved but we can do more to raise awareness. Door stickers will be provided for residents and signs erected in the identified zone. Trading Standards, Highways, NPT &amp; Division Councillor will work together to deliver this project. A site visit has taken place; an assessment carried out by Trading Standards has confirmed this location is appropriate for the pilot.;</i></p>

<b>What evidence is there that this project/activity needs to take place/be funded by the area board?</b>	A number of incidents occurred in this area of Chippenham in December 2013. Residents have expressed concern		

<b>How will the local community benefit?</b>	Reduction in doorstep crime and the number of victims. Reduction in anxiety and inconvenience, particularly for elderly and vulnerable caused by cold callers. Trading standards has worked with Utility companies and a Code of Practice has been adopted a Code of Practice which states that companies don't call at homes displaying No Caller stickers or enter designated no cold calling zones. If succesful, this pilot will be rolled out across Wiltshire
