Introduction

What is the Pewsey Community Area Partnership (PCAP)?

PCAP is autonomous and independent; it is inclusive of, and accountable to our wider Community Area. It has a voluntary relationship with the Council and public agencies and helps to form the basis of a strong, resilient and empowered Pewsey Area Community. PCAP aims to create active and sustained participation by all sections of the community that will lead to public funding and services to be more accurately allocated to the wider priority needs. PCAP consults widely on a range of the community issues and holds public engagement events and activities to further involve every member of the community.

The Pewsey Community Area covers the following parishes (26 in total, * indicates parishes have combined):

Alton, Beechingstoke, Burbage, Buttermere, *Charlton and Wilsford, Chirton & Conock, Easton, Grafton, Great Bedwyn, Ham, Little Bedwyn, Manningford, Marden, Milton Lilbourne, North Newnton, Patney, Pewsey, Rushall, Shalbourne, Stanton St Bernard, Upavon, *Wilcot & Huish (with Oare), Woodborough, Wootton Rivers.

What is the Community Plan (CP)?

The CP sets out ideas and priorities for each subject area. Each of these ideas, based on priority, form the basis of consultation with the community to identify what actions the community would like to see happen. Those actions may then be delivered by Wiltshire Council, other services, voluntary organisations or Parish Councils, or indeed a combination of these organisations. PCAP's role is to identify the actions and to assist in realising the projects or changes required.

How is PCAP organised?

PCAP is made up of a group of volunteers, all living and working within the Pewsey Community Area and who meet every quarter. There is an elected (by the group) Chairman and Vice Chairman who are advised by the heads of a number of active sub-groups, who help to progress the local issues. The terms of reference for each group are broadly based upon the following principles:

- To create and update the relevant section within the Community Plan
- To advise the Partnership on the contents of their section of the plan and to keep a watching brief on the targets within its theme and report progress to the Partnership
- To recommend any presentations or speakers they feel are appropriate and necessary for the Partnership agenda


Format of the Community Plan

Section A - PCAP Guiding Statements

1. Overall Guiding Statements

The following guiding statements overarch all the guiding statements detailed in each of the Sub-Groups.

S1.01	Sustainability	The community must respond flexibly to the many changes it faces. Any actions taken should not spoil what the community has - but protect and improve things for the future. In that context, PCAP's aim is to create a more self-reliant community and this includes supporting the main village of Pewsey as the Service Centre without overlooking the wider Pewsey parishes. We have maintained a local focus within this plan but observe the aims and objectives of the Unitary Council's Strategies.
S1.02	Community Area Vision	The Pewsey Community Area is a living and working countryside; it will continue to be a beautiful natural environment with a strong community spirit and plenty of local involvement. Access to education, health, social care, housing and policing will be available to everyone in the Community Area and all sections of the community area will be able to participate in decision making.



2. Countryside & Environment

The majority of the Pewsey Community Area is set within the North Wessex Downs Area of Outstanding Natural Beauty (NWD AONB). The Pewsey Community Area is made up of 26 parishes and is very rural, made up entirely of villages rather than any towns.

Pewsey is the largest village in the Community Area and the local service centre. As a heritage village, it is supported by a locally distinctive environment which is essential to the quality of life in the Pewsey Community Area. Local people generally want to support the development of local products in the craft based and agricultural industries and are supportive of the move to promote tourism for the area.

The importance of the Kennet & Avon Canal and access to major national monuments, such as the World Heritage Site at Avebury and Stonehenge, enhance the attractiveness of the area. In addition, the community area is rich in wildlife and is especially strong in the provision of woodland areas and chalk downland.

External groups who are consulted on environmental matters include:

3. Education & Lifelong Learning

The Pewsey Community Area has xx primary schools and one secondary school, Pewsey Vale, which is an arts academy. Secondary school pupils from the Pewsey Community Area may attend St John's School in Marlborough. There are xx private primary schools and xx private secondary schools in the area as well.

College facilities exist at Swindon, Andover and Salisbury.

The local adult community needs the opportunity to learn new skills - traditional and modern - and easy access to training to enable them to take a fuller part in developing community life and to contribute to the economic development of the area.

4. Housing & Local Development

Pewsey Parish Council set up a Working Group in 2012 to produce a Pewsey Neighbourhood Development Plan (NDP). This plan sets out the development required for the Parish of Pewsey until 2026 based on the Wiltshire Council Core Strategy and local community requirements.

Other parishes in the Community Area are able to adopt a similar way forward if desired. As at April 2014, the only other village in the process of doing so is Burbage.

As of April 2014, the Wiltshire Core Strategy has not yet been adopted.

5. Transport & Highways

Good transport facilities are vital for the well-being of a rural community as people need access to all forms of transport for work and leisure purposes. There is a need to create better transport facilities in the area for the most vulnerable in society, even though car ownership in the community area is high. In addition there were serious concerns expressed about the quality of the road surfaces and specific examples where improvements could be made such as the clearing of ditches to avoid flooding.

To maintain the rural nature of the area and avoid excessive intrusion into the countryside by increasing traffic volumes it will be important to find schemes to allow people to move around freely whilst protecting the countryside.

There is a need to reduce the increasing number of deaths on Wiltshire's roads. There is also an increasing problem of Satellite navigation technology and speeding on rural roads.

There are a number of forums and action groups for various elements of transport. The Community Area Transport Group (CATG) is the Wiltshire Council's formalised body with delegated responsibilities and a reporting chain. CATG investigates the local transport issues and makes its recommendations to the Pewsey Area Board.

6. Crime & Community Safety

The Pewsey Community Area runs the Pewsey Area Crime & Community Safety (PACCS) forum, which meets every quarter to:

- review the priorities of the Neighbourhood Policing Teams;
- develop and monitor local actions plans to tackle the key issues identified;
- report to PCAP by means of minutes, on progress;
- consider crime and safety problems within the Community Area, including road safety;
- consider projects and initiatives to help reduce crime and the fear of crime.

The PACCS meeting is open to all parishes in the Pewsey Community Area and other representatives include the Neighbourhood Policing Team, Wiltshire and local Fire & Rescue, Youth Development Service, Licensing, Neighbourhood Watch and EPIC (Employment Prospects Improvement Club). Other interested parties will be invited if there is a relevant agenda item, e.g. Canal & River Trust.

The Pewsey Community Area is policed by two local Neighbourhood Policing Teams, both based in Pewsey (Pewsey West and Pewsey East).

7. Culture, Heritage & Leisure

A thriving cultural environment brings the community together.

Pewsey village is home to the Shak, the local youth and Sports Centre, which is hugely popular for providing activities for teenagers.

The annual Pewsey Carnival in September is a spectacular event involving over 500 local people in its creation and 25,000 spectators. It is the glue which cements the Pewsey village community together and projects a "can do" image for the village reflecting the considerable voluntary commitment and strong community spirit. This provides the village and the surrounding vale with a strong feeling of identity.

8. Economy

The service centre for the Pewsey Community Area is Pewsey village.

The Community Area is very rural and therefore relies heavily on farming and related industries as well as tourism.

Because of its rural nature, the area has a limited public transport service. Road and rail links are relatively good, with two mainline stations in the area (Pewsey and Great Bedwyn).

Markets operate in Pewsey and Burbage. Pewsey has an outdoor and indoor (craft) market every Tuesday at Bouverie Hall and a Farmers' Market on the second Thursday every month from 9am to 1pm. Burbage market takes place on the second Saturday of every month from February to December from 10am to 3pm.

9. Health & Social Care

The Health and Care Forum is in place and explores issues of health and care concerns of local people within the community area with the partner agencies who provide health and social care services locally. A series of Public Health Forum meetings took place during 2013 to identify issues. Many of these are at a Wiltshire or South West England level, rather than at a local Pewsey Community Area level. It is therefore proposed that the feedback capture will continue with the results being fed back at a higher level (exact communications route is yet to be confirmed). Any residual local issues will be progressed via the PCAP Action Plan.

There is no hospital facility in the Community Area - the nearest is in Marlborough, 7 miles away with A&E and minor injuries available at Swindon and Salisbury. There are four GP's practices in the community area (Pewsey, Burbage, Upavon and Great Bedwyn), and three dental practices (Vale, Pewsey and Burbage).

Pewsey was home to a hospital for people with learning disabilities which closed and those who now live in the community as a result of the closure require increasing amounts of care as they get older. In addition, difficulties occur for special needs groups when travelling to and from hospital.

Increased demand for housing specifically catering for older people will become more important as the population aged 65 and above increases, as is predicted. An aging population is likely to result in increased demand for health services and social care.

Army rebasing, whilst focused around Tidworth and Larkhill will lead to increased demands on local services especially health care, since many families are likely to opt to live in the surrounding areas rather than in Army provided accommodation.
