Wiltshire Council has a strong commitment to sustainability and combating climate change, so increased awareness of environmental issues amongst teachers and their pupils will contribute to this aim. The Food Festival will make people more aware of local food production, which is more sustainable. How did you discover there was a need for your project and how will your project benefit your local community? Important: Please do not type in paragraphs - This section is limited to 1200 characters only (inclusive of spaces) The Ecoschools conference idea came from discussions with Head Teachers from local schools, who were very keen to share best practices and increase their focus on sustainability. The benefits would be reduced energy costs for schools and increased awareness of sustainability issues amongst pupils and their families, in turn leading to reduced energy domestic bills, lower carbon emissions from the school run, and increased appreciation of the importance of biodiversity. The Food Festival idea came from discussions with local food producers and distributors, stimulated by the Corsham town market and Farmers' market, and also feedback from members of the public attending other Transcoco food-focused events. All felt it would be a great idea to celebrate local food production in a festival, which if successful could become an annual event. The benefits would include greater awareness of local food production and trading, supporting the local economy and reducing carbon emissions associated with 'food miles'.
