(a) Motions previously considered – Reporting Back

The following notice of motion was presented to Council on 22 February 2006 and referred to the Scrutiny Committee which considered it at its meeting on 19 April 2006:

(i) Reducing Accidents in Melksham North Ward – Cllrs Barker and Chivers

"This Council notes with great concern that the ward of Melksham North finds itself in the top third of wards in England and Wales for road accidents related injuries to under 16 year olds and over 60 year olds. After research by the Child Accident Prevention Trust.

Between 2000 and 2003 17 accidents occurred to under 16 year olds and 60 year olds at a cost of £1,118,430 to society. This information is from Police Date and the project has been funded by The Department of Health. As a matter of urgency this Council works with its partners such as Wiltshire County Council, Melksham Town Council and West Wiltshire Housing Society and others in a bid to reduce accident rates within this ward.

In doing so it may be possible to meet the Government target of reducing accidents to the young and old by 50% by the year 2010."

The Scrutiny Committee noted that a similarly worded notice of motion had also been considered by the County Council which had resolved: "To note that based on the most recent three year casualty data, Melksham does not have a child pedestrian safety problem".

In view of the County Council's resolution, the Scrutiny Committee had recommended that no further action be taken on this notice of motion given the findings of the Wiltshire County Council.

RESOLVED:

That the recommendation of the Scrutiny Committee be accepted and that the above notice of motion be not adopted.

(i) Appraisal of Development Control and Enforcement FunctionsClirs Phillips and Clark

The following notice of motion was presented to Council on 12 April 2006 and referred to Cabinet to consider the resource implications of such a motion:

"This motion requests the Council to carry out a thorough appraisal of the development control and enforcement functions of the planning department, particularly in the light of the withdrawing over a period of the government's planning delivery grant. This is in order to ensure that the department is capable of carrying out its statutory functions in respect of dealing with planning applications and carrying out enforcement for contravention purposes."

"In the light of the information given on the Members' Information Sheet no. 556 with regard to the Boundary Committee, this motion asks the Council to reconsider the decision not to make any submissions to the Boundary Committee on the proposed reorganisation, bearing in mind that this Authority

has a responsibility to act for its members in matters such as this, and the proposal by the Boundary Committee to incorporate combinations of rural and town seats is contrary to their own policy.

Bearing in mind the time scale for submissions of the 22nd May, we ask that this matter is addressed urgently by the officers of the Authority in conjunction with members direct."

In presenting the motion, Cllr Phillips explained that he agreed with the submission made by Trowbridge Town Council and the Council should be making its views strongly to the Boundary Committee.

Council considered a report of the Chief Executive which gave the background to the Boundary Committee Review and explained the time scales involved and the next steps remaining in the timetable.

It was explained that it was not considered feasible at this stage to submit another scheme on behalf of the Council. The approach of the Boundary Committee had clearly shown that the Council's time would not be effectively employed in submitting another scheme. The Chief Executive did however point out that he would be meeting with representatives of the Boundary Committee when he would reinforce the stance previously made by Members. Members could also send any further comments individually direct to the Boundary Committee and it would be helpful if any such comments could be copied to the Chief Executive.

- To note the process and that the Council would not be submitting a revised proposal.
- The Chief Executive on behalf of the Council would prepare a submission to reinforce Members' views and any common themes.
