Amended Recommendations/Directives

06/03164/FUL - Whitepits Farm 34 - 35 Kingston Deverill

The Committee agreed with the Officer's recommendation for consent, but with the following additional conditions:

 The property as a whole, the farmhouse and the detached garage, workshop and studio, shall be occupied as one dwelling unit, with the accommodation hereby permitted occupied as part of, or an extension to, the main dwelling and it shall not be let or sold as separate unit of accommodation.

REASON: Because the creation of a separate dwelling unit would be contrary to planning policy in this area.

POLICY: West Wiltshire District Plan - 1st Alteration 2004 - Policy H19.

2) Notwithstanding the provisions of the Town & Country Planning (General Permitted Development) Order 1995, as amended, no development falling within Schedule 2, Part 1, Class E; of the Order shall be carried out to the detached garage, workshop and studio without the express planning permission of the Local Planning Authority.

REASON: The implementation of permitted development rights on this site would be unacceptable.

POLICY: West Wiltshire District Plan – 1st Alteration 2004 - Policies C27 & C28.

06/03403/OUT - Land Adjacent 22 Cherry Orchard Codford

The Committee agreed with the Officer's recommendation for consent, but with the following additional condition:

The proposed 9 parking spaces identified on the plan received by the Local Planning Authority on 9th February 2007, together with any access thereto, shall be provided concurrently with the development hereby approved and subsequently retained.

REASON: To ensure that an adequate area for parking is available in the interests of highway safety.

06/02424/OUT - Areas R11 and R12 Westbury Leigh Westbury

Permission following S106 agreement as recommendation but change to recommendation as follows:

Third indent to read – the provision of **land for** a doctor's surgery Add indent at end – the provision of an agreed sum for education needs

Applications Deferred

Officers recommended that listed building consent be granted. However the Committee resolved to defer the application pending further information on i) the views of the Trustees of the Saxon Church, ii) clarification on the position of the base of the original wall and structural integrity of any future construction on top of cistern.

Decisions Made Against Officers' Recommendation

06/02441/FUL - Land Rear Of 69 Woolley Street Bradford On Avon

Officers recommended the above application for permission. However, the Committee resolved to refuse the application for the following reasons:

1) The proposal by reason of its overall design, density and layout would neither preserve nor enhance the character or appearance of the conservation area contrary to Policies C17 & C18 of the West Wiltshire District Plan – 1^{st} Alteration 2004, and would, furthermore, disrupt the character of Coronation Avenue and the surrounding area contrary to Policies H1 and H24 of the West Wiltshire District Plan – 1^{st} Alteration 2004.

2) The proposal by reason of its layout does not make provision for the protection of existing TPO trees contrary to Policy C32 of the West Wiltshire District Plan -1^{st} Alteration 2004.

06/03666/FUL - Hortons House 15 Church Street Bradford On Avon

Officers recommended the above application for permission. However, the Committee resolved to refuse the application for the following reasons: -

1) The proposal would by reason of the use of timber, result in an inappropriate material that would neither preserve nor enhance the character or appearance of the Conservation Area contrary to Policies C17 & C18 of the West Wiltshire District Plan -1^{st} Alteration 2004.

2) The proposal would by reason of the use of timber, result in an inappropriate material that would harm the character and setting of the surrounding Listed Buildings in particular the Grade I Listed Saxon Church contrary to Policies C27 & C28 of the West Wiltshire District Plan – 1^{st} Alteration 2004.

RESOLVED:
