Amended Recommendations/Directives

<u>06/03372/FUL – Construction of a new skateboard park – Stallard Recreation</u> <u>Ground, Stallard Street, Trowbridge</u>

The Committee agreed with the Officer's recommendations for consent, but with the following amended condition:

Condition 4 - Prior to the commencement of development of the site, the applicant shall submit details of a management program for the skateboard park which shall include a maintenance regime and the provision of surveillance measures. Liability for overall maintenance of the development shall rest with the applicant and shall remain so in perpetuity unless the Local Planning Authority has agreed alternative arrangements in writing.

REASON: In the interests of ensuring that the site is properly maintained. Informatives to read as follows:

- 1) The applicant is advised that local bylaws prohibit the use of bicycles in the park.
- 2) The applicant is advised to liaise with local residents with regard to prevention of anti-social behaviour.

Applications deferred

<u>06/02785/FUL – Construction of three golf holes – change of use from</u> <u>agricultural land to recreation – Land North West of Leigh Grove Farm, Leigh</u> <u>Grove, Bradford on Avon</u>

Officer's recommended that planning permission be granted, However the Committee resolved to defer the application.

Decisions made against Officers recommendations

<u>06/01257/OUT – Construction of business park (B1 and B8 uses) – Land off</u> Bradford Road, Trowbridge

Officers recommended the above application for permission. However the Committee resolved to refuse the application for the following reasons:

1 The proposal would, by reason of its siting, scale and type of use significantly increase the traffic flow onto the A363 and through Bradford on Avon to the detriment of the local highway conditions contrary to policy E2 of the West Wiltshire District Plan - 1st Alteration, 2004.

2 The development proposed would, by reason of its location, siting and access road impinge on the Green Belt and reduce the rural buffer between the two towns of Trowbridge and Bradford on Avon contrary to policy E2 of the West Wiltshire District Plan - 1st Alteration, 2004.

3 The proposal would, by virtue of its location, access and proposed development, be sited and cause problems within the flood plain contrary to policy U2 and E2 of the West Wiltshire
