50. MINUTES

52. CHAIRMAN'S ANNOUNCEMENTS

The Chairman made the following announcements:

- Welcomed Cllr Peter Leach who had been appointed as the Town Council Representative on the Standards Committee.
- Following the last meeting of the Standards Committee it was resolved that
 the Solicitor in collaboration with the Chairman of the Standards Committee
 write to the Standards Board for England in a plea for some relief of costs
 being incurred from Local Determination Hearings. The Chairman drew the
 Committees attention to the letter the Standards Board for England had
 written in response to the request. The implications would be discussed at a
 future meeting.

53. ANNUAL REPORT OF THE WORK OF THE STANDARDS COMMITTEE

The Chairman asked the Standards Committee to discuss and consider the contents of its Annual Report. A draft of this would be presented to the next meeting of the Committee and approval of the report would be at the February meeting.

A summary of the Committees discussion and the incorporations into the Annual Report was as follows: -

- The last Annual Report was informative, however needed more work.
- Local Determination Hearing How it was handled and how the Committee would manage future Hearings.
- What the Standards Committee had accomplished as well as what it had not, what it would have liked to have achieved and what it would like to do in the future, if resources are available.
- The role of the Standards Committee in reviewing the constitution.
- A profile of each Standards Committee Members.
- The composition of the Committee and reason for composition.

After approval the Annual Report would be distributed to all Town and Parish Councils and the County Council. It would also be sent to Council for noting and available on the website. The Chairman would write an article for West Wilts Matters to inform the public that copies would be available from the Council.

54. WORK PROGRAMME

The Committee expressed concern that there was need to review the constitution, especially considering the cost to produce, so soon after adoption.

Cllr Clark felt that the constitution needed to be clear and concise and not open to interpretation.

Cllr J Clegg commented that regularly, planning applications were called into the Planning Committee without valid reasons, or without representations at the meeting of the person/Council who had called the application to Committee. He felt that this was an area, which needed addressing in the constitution.

The Chairman and Vice Chairman of the Standards Committee would be meeting with the Solicitor to discuss the areas of the constitution which needed to be reviewed prior to the meetings of the Standards Committee on 12 December and 1 February 2007. It was
