The Task Group has identified further work, which it will carry out throughout November. It will also monitor the end of the Pathways for Change engagement process and will formulate the Health Overview & Scrutiny Committee's response to proposals for future health services.

The Task Group has identified some early recommendations, regarding the closure of Bradford on Avon hospital and partial closure of Westbury hospital, which are outlined in the report.

The Committee is asked to note the ongoing work plan of the Task Group, consider the early recommendations put forward in the report and to formally put forward the recommendations to West Wiltshire Primary Care Trust.
