6. Health Service Reconfiguration in Wiltshire

The Board of Wiltshire Primary Care Trust met on 30 January to make its final decisions for service reconfiguration in Wiltshire, bringing together the conclusion of the consultation on Pathways for Change and two primary care developments for South Wiltshire, which had been instigated prior to the PCT merger in October 2006.

The Board made a number of key decisions regarding the future of community hospitals in Wiltshire, reconfiguration of certain services, the development of primary care centres and the establishment of 24 hour neighbourhood teams.

Members will receive a report by the Pathways for Change Task Group which outlines the Task Group's consideration of the decisions and their implications for Wiltshire.

The Committee is asked to endorse the conclusions and findings in the Task Group report and to forward these as necessary to the appropriate bodies for consideration and response.

Good scrutiny practice dictates that the Committee should review the implementation of these recommendations in twelve months time, however in respect of this issue

the Committee is asked to authorise the Task Group to continue its role in monitoring developments and implementation.
