CFAG was set up to support families and children in deprived circumstances. We provide trips and workshops for the children and their families throughout school holiday times providing the children with experiences they'd not have the chance to enjoy when finances are sheltered by being on long term benefits or low income. Some of the children are from families where there are drugs and alcohol problems or family breakdown.

The girls group has been formed as a result of consultation carried out by CFAG at the Calne Community And Learning Centre's fun day last summer. The group takes part in weekly meetings where they become involved in arts, crafts, dance etc. In addition the group is starting to become interested and involved in learning more about domestic skills, such as cooking and about technological skills around computers and IT.

This trip will be an opportunity for these young people to gain an insight into broader experiences that might be of further interest to the group and to individuals.
