Chairman's update Calne Community Area Board 25th August 2009

Review of the Community Area Plan

The Community Area Partnership provided a draft version of the revised Community Area Plan to the last Area Board meeting. The Area Board is expecting to receive a final version at the October meeting so that it may be fed into the Wiltshire Council budget consultation process, the Partnership will provide an update of how this piece of work is progressing at this evenings meeting.

Wiltshire Fire & Rescue Service

A leaflet has been circulated with the agenda for this meeting asking people to engage in a consultation event being run by Wiltshire Fire and Rescue Service. In due course the results of this exercise will be shared with the Area Board, Community Partnership and other Partners and represents an example of the ways in which we all hope to share information and undertake consultation in a more joined up fashion in an attempt to reduce and avoid community consultation overload.
