Attachment 1

How to place an item on the Agenda of the Health Overview and Scrutiny Committee

- 1. Any member of an health overview and scrutiny committee shall be entitled to give notice to the Deputy Chief Executive that he/she wishes an item relevant to the functions of the committee to be included on the agenda for the next available meeting of the committee. On receipt of such a request the Deputy Chief Executive will ensure that it is included on the next available agenda.
- 2. The Leader of the opposition may on up to 4 occasions per year require the Deputy Chief Executive to include an item on the agenda of health overview and scrutiny committee for consideration. The Director of Corporate Services shall inform the chair of the health overview and scrutiny committee of the request at the earliest opportunity, and make arrangements for the matter to be included on the agenda at the next available meeting of that health overview and scrutiny committee.
 - (**Please note that the 'Leader' above refers to all opposition party leaders)
- 3. **Any 5 members of the Council** may give written notice to Deputy Chief Executive that they wish an item to be included on the agenda of the health overview and scrutiny committee. If Deputy Chief Executive receives such a notification, then he/she will include the item on the first available agenda of the overview and scrutiny committee for consideration by the committee.
