## CO25. Area 4 Community Area Funding Distribution 2005/06

Consideration was given to Report No. 6 (circulated with the Agenda) asking Members to consider 3 applications seeking 2005/2006 Community Area Award funding.

Representations were received from Mrs M. Carey, Clerk to Box Parish Council.

Issues discussed included:

- The positive nature of the work carried out by Relate Mid Wiltshire;
- The loss of links between Relate Mid Wiltshire and Councillors;
- The dependency of the Box Pavilion application on lottery funding;
- The maintenance of the proposed Pavilion; and
- That the Box Pavilion application would represent a large drain on the capital budget.

#### **Resolved** that

- (1) the Committee agree funding distribution of the Area 4 Community Area Awards budget based on the agreed criteria for 2005/2006;
- (2) Steam Back to Box Award £465 from the revenue budget for advertising and promoting and competition prizes for local schoolchildren, for the "Steam Back to Box" event to celebrate the Brunel 200;
- (3) Relate Mid Wiltshire Award £2,700 from the revenue budget, for counselling service for young people, conditional upon all other funding being in place;
- (4) Box Parish Council- Rescind previous in principal award of £14,330 made on 18<sup>th</sup> January 2005. Award £30,000 from the capital budget for a sports pavilion, conditional upon all other funding being in place, and refer to the Executive Capital Partnership Funding Scheme. The applicant should be advised that it would not be possible to rescind this award and make a third application.

## CO26. Representatives to Outside Bodies

Consideration was given to Report No. 7 (circulated with the Agenda), enabling those Members appointed to outside bodies to update the Committee on any topical issues.

Issues discussed included:

- (Joint Services Liaison Panel) Equipment from Spring Quarry is starting to emerge, a virtual tour of the site is available on the BBC Web-site; and
- Potley & Pockeridge Community Association has a new resident taking over the running of the facility. The computers and Tiny-Tots Club are facilities both used and appreciated by the community.
