Most members have only small incomes; subscriptions cover day to day costs but are insufficient to provide high quality printed material nor to hire suitable public halls. Potential benefits accrue to all over-55s in local area, whether members or not, and whatever their personal circumstances.

Current members' subscriptions will support public engagement to a small extent, and failure of this application will limit activities. We envisage that a similar application will continue to be necessary in future years for us to continue with our work.

These are not always easy to access. The Forum has a small voluntary committee and some 170 members who pay a small subscription. The objective, however, is to be of value to all senior citizens in the area, hence the need for regular meetings and the newsletter.
