## **Community Speedwatch**

Inspector David Cullop introduced a new Community Speed Watch Scheme where local people can get actively involved in road safety.

Local residents, who are willing to volunteer a small amount of time each week, are able to monitor speeds with speed detection equipment in their community.

If you think there is a speeding issue in your area, please fill in an issue sheet and return it to Elly Townsend. Issue sheets are available online or in the Bradford on Avon Library. This issue will then be assessed by the Police to see if it can be tackled by the Community Speed Watch Scheme.

## **Traffic Issues**



Martin Moyes from the Safer Communities Action Group gave a presentation on the concerns of local residents regarding the intimidation of pedestrians and cyclists by motor vehicles. A number of traffic issues were discussed, including the problems caused by Heavy Goods Vehicles and vehicles travelling inappropriate speeds.

It was agreed that representatives from the Safer Community Action Group would meet with Wiltshire Council officers to have a roundtable discussion about the issues raised. This meeting will take place in early December.

## **Kingston Mill Development**



Edward Nash from Nash Partnership presented new proposals for the Kingston Mill site ahead of

applying for amended Planning Application from Wiltshire Council.

Potential changes to the site include:

- An increased concentration of shops within Lamb Yard
- A spreading out of new employment workspace accommodation around the whole of Kingston Court
- An increase in the floor space given to new riverside restaurant activity and associated open-air seating areas, including the possibility of a roof top restaurant by the Town Bridge, enjoying magnificent views;
- The removal of the 3,000 sq ft possible facility for Community Use previously offered when it was then anticipated the Lamb Yard development would be taken forward and managed by a previous development partner.

A public consultation event took place at the Bradford on Avon Library on the 3<sup>rd</sup> October. Linden Homes will review all the comments received during the consultation process and are working to submit an amended planning application by the middle of October. Once submitted, this planning application will be open to further public consultation.

# Community Grants Awarded

Sukosta Theatre Company and Bradford on Avon Senior Citizens forum were both successful in their applications to the area board for community area grants. Sukosta, a Bradford on Avon based Theatre Company has been awarded £2,900 to deliver outreach theatre activities with older people and young people. Bradford on Avon Senior Citizen's Forum were awarded £500 to run information events and to produce a newsletter for older people across the community area.

Match-funded grants of up to £5,000 are still available. See <u>www.wiltshire.gov.uk/areaboards</u> for more information. The next round of grants will be considered at the next area board meeting on 11 November.

## **Performance Reward Grant**

Wiltshire Council is working together with other organisations including the police, NHS, the fire service and the voluntary and business sectors across the county towards:

£2.8m is available over two to three years for bids from Area Boards that propose initiatives that take forward these priorities.
