At the end of the consultation the feedback and information received will be analysed by an independent organisation. Following this the Primary Care Trust Boards will meet to consider the options using the feedback and clinical information they have gathered during the consultation. The Health Overview & Scrutiny Committee retains the legal right to challenge the decisions through the appropriate channels should it deem the decisions to be unacceptable.

## 7. Mainstreaming Mental Health
