1.0 Introduction

1.1 What is a Foundation Trust?

A Foundation Trust is a new type of NHS organisation. It employs NHS staff, treats NHS patients, free of charge, maintains NHS principles and remains a public sector organisation. This paper will explain Swindon and Marlborough NHS Trusts bid to become a Foundation Trust and provides an update on the paper presented to the Wiltshire Health Scrutiny Committee on 20th September 2007.

1.2 An Independent Legal Entity

A Foundation Trust is an independent legal entity with greater freedom to manage its own affairs, with a Board of Directors acting as a corporate Board, and a Council of governors elected by the membership.

It has certain freedoms; freedom from the Strategic Health Authority control but still subject to national standards and performance targets; freedom in the way the Foundation Trust may plan and make decisions. With freedom comes constraint: Foundation Trusts may not withdraw from providing services without obtaining commissioner support and /or ensuring alternative provision is available. If a PCT wishes to purchase a particular service on behalf of its population that service must be provided unless there are clear clinical reasons why they should not. A Foundation Trust may not neglect their responsibilities to the NHS or give priority to private patients.

1.3 Independently regulated.

Foundation Trusts: are

- Authorised by, accountable to and regulated by an independent regulator Monitor,
- Awarded a licence to operate under terms of authorisation which outline core services and regulations
- Required to maintain the same quality standards as other NHS organisations
- Required to have independent inspections such as those by the Healthcare Commission.

1.4 Better and more inclusive governance

Foundation Trusts are membership organisations. They must have

- Local ownership and involvement through governors and members who represent patients, carers, the local community, stakeholders and staff
- A Council of Governors who have key responsibilities including the appointment of the Chair, Non Executive Directors and the external auditors and approving the appointment of the Chief Executive
- Greater quality and transparency in governance

Through membership and the Board of Governors we aim:

- To Increase and improve communication with stakeholders
- To form stronger links formed with local people of Wiltshire and Swindon
- To ensure that the needs of local people will be at the heart of what the organisation does.

1.5 <u>Financial freedoms</u>

Foundation Trust status will enable us to manage our own finances and budgets through:

- Binding contracts with commissioners
- Greater financial flexibility
- Ability to generate and retain surpluses and reinvest them in services for the benefit of the organisation
- Ability to borrow money to fund capital and service developments
- The protection of NHS assets. It is not about privatisation.

1.6 <u>Organisational Freedoms</u>

The benefits include

- The ability to make decisions at a local level
- The freedom to develop services in a more timely, appropriate and responsive way to meet the needs of patients
- Local decision making on capital investments to improve services and increase capacity
- The ability to start new capital projects more quickly

The Monitor assessment phase lasts for over approximately 12 weeks. It includes

- The Trust submits its application to Monitor. This contains:
 - o the Business plan and financial model
 - o Constitution and governance submissions
- An Assessment of Application. This includes
 - Interviews with Trust
 - Review of robustness of financial model assumptions
 - o Interviews with external stakeholders
- A Board to Board Meeting. The Trust Board is interviewed by Monitor's Board.

3.0 Commissioner Update.

The basis of our application to Monitor is the Integrated Business Plan (IBP) and long term financial model. The activity assumptions contained in our business plan have been reviewed with our lead commissioners - Wiltshire and Swindon Primary Care Trusts - so that the IBP correlates with the plans of the PCTs.

Useful feedback has been received from our Primary Care Trusts and we look forward to ensuring our strategic plans are aligned in order to bring about improvements in public health.

4.0 Outcome of Foundation Trust Consultation

In the previous report to Wiltshire Overview and Scrutiny Committee, the outcome of the consultation had not been finalised. The following is a summary of the responses we received.

4.5 Information giving sessions / Public shows and events attended

We have given out information on the streets of Swindon, Chippenham, Devizes, and Marlborough. We also held information giving sessions at local employers such as the headquarters of the Nationwide Building Society, and at local major supermarkets.

We attended various shows and fetes in the area;

Several hundred people were spoken to and given information at the above events.

In addition information was given out at the Great Western Hospital Open Day held on 15 September 2007 – with around 350 members of the public attending.

We have also talked about our Foundation Trust bid on local radio stations Brunel FM, BBC Radio Wiltshire, BBC Radio Swindon and on our Hospital Radio. Articles have appeared in all local papers.

Numbers of people contacted through these mediums have been estimated to be 300-400.

4.7 Hard to Reach Groups

To ensure that "hard to reach communities" received information and could respond to the consultation relevant stakeholder groups and individuals in these communities were approached and provided with details of the consultation. This included community groups representing old and young communities and BME populations.

As an example, the Clivey Project is a charity working with and supporting young people in Swindon – particularly those living in Swindon's deprived areas. The charity was fully briefed about our consultation and will continue to be an important way for the Trust to access views and opinions from young people in Swindon.

Information was also made available in Libraries and GP Surgeries and The Westlea Housing Association included information within their newsletter. We also gave out information on high streets of local towns and in local supermarkets.

4.8 Information sent out

16,000 consultation documents were distributed. These included a feedback form which included eleven consultation questions. In addition to being given out at all of the events listed above, these were also sent to:

Consultation documents were available around the hospital for patients, visitors and staff. The full range of consultation documents was also made available through our website.

The Trust used existing communication channels to raise awareness of the consultation internally - including the staff intranet, site communications, posters around the hospital and staff briefings.

A 10 metre banner was displayed at the entrance to the Great Western Hospital site, advertising the consultation. In addition, 5 banner displays were erected in the atrium to the Great Western giving more details on the consultation.

Our Annual Report also included details of the FT application.

119 Pro-forma consultation feedback forms were received. These were assessed and logged onto an in-house Access database and the feedback analysed. This feedback is noted in the table below which shows the percentages in favour of or opposed to.

The overwhelming tone of the responses was supportive and positive. The responses received demonstrate enthusiasm for the greater local accountability that FT status will bring and for public membership.

Specific issues in regards to community services, such as the closure of a local minor injuries unit by Wiltshire PCT were raised in some responses from members who were confused as to who offered which service in the local area.

Some minor issues and objections were also raised in response to specific personal experiences or the reputation of the hospital as perceived through media reports.

Negative comments received were often related to whether FT status would mean more layers of management being required by the Trust.

As a whole though negative responses received were minimal and where it was it tended to be specific to personal experience.

The main areas that attracted critical comments are listed below. However it has to be reported that as a whole people were happy with the Trusts proposals as they stand.

input? Do they really have enough life experience to make decisions?	Board debated the feedback to this issue at its October meeting and agreed to maintain a minimum age of 12 for membership. The Trust feels that it is appropriate for the children who use our services to have a say in how we deliver those services. Potential abuse of the system by a small number of parents shouldn't be allowed to prevent the Trust from doing the right thing. We will work with the Electoral Reform Society to ensure that we do everything that we reasonably can to ensure fair Governor Elections.
	review and further develop our communication and engagement with younger members. This will be addressed as part of our membership development strategy.
Is Foundation Trust status a way of privatising the NHS – will we still adhere to Department of Health standards	Foundation Trusts are fully part of the NHS with a legal duty to provide a comprehensive range of services free at the point of need. National Targets will still need to be met and FTs have a legal duty of partnership. We have continually communicated this message throughout the consultation.
How much was the consultation and bid process and publicity etc costing	We have allocated a one off cost of 300k towards our Foundation Trust application. Of this 30k was used for publicity and producing materials for the consultation phase.
Why are we consulting when we know the government say we have to make the change anyway	We have explicitly stated throughout that the consultation was not a vote on whether we became a Foundation Trust, but was a consultation on our proposals surrounding our future strategic direction and how the FT would operate.
The catchment area of the trust being expanded – will this effect care being given to current patients and will it put too much pressure on staff	As referenced in our business plan we only look to increase our catchment area within those specialities where we have capacity to do so safely and efficiently.
Why was Thames Valley Chamber of Commerce represented on the Board of Governors	It was explained to all commenting on this that this was in fact the local chamber despite then name suggesting it was out of our geographical area. We are keen to engage local employers and businesses.
How will our PFI status effect our bid	We have stated that the additional levels of fixed costs associated with our PFI status present particular financial challenges for the Trust in terms of our application; however the excellent hospital environment in which we operate is an asset and a strength.

One of the questions asked during the Consultation was "What one thing would you like to see us achieve within our first 3 years as a Foundation Trust? The key areas raised in response to this question are listed below with the Trusts response.


Issue	Trust's response
Reductions in Waiting Times	This issue is addressed within our Business Plan. We are committed to delivering national access targets and will explore areas where we can exceed national waiting times targets.
Provide easy access to your services for those patients who live further away from the hospital, including those in more rural areas.	As part of our business plan we are looking at providing more clinics in communities that have difficulty accessing the Great Western Hospital. We will also continue to invest in subsidizing bus routes and work with local councils on these issues.
Evening and weekend clinics and operating	The Trust is committed to improving access to services and, although currently there are no specific plans in place for providing more clinics and operating outside of normal hours – we are reviewing this.
Improve the way staff communicate with patients within the Hospital.	We will review staff education and training to ensure we focus on this issue.
Improve the image of the Trust portrayed through the local Media.	The Trust will ensure this area is addressed through its future Communication Strategy.
Reduce Infection Rates	An action plan is already in place to ensure the Trust complies with best practice and national guidance in this area. Infection Prevention and Control will continue to be given a very high priority within the Trust.
Reduce Car Parking Charges	A proposal regarding car parking charging will be presented to Trust Board. This proposal is unlikely to recommend a reduction in total car parking charges but will recommend a fairer structure of charges.


4.10 What were the main areas attracting support locally?


- Greater local accountability through membership and governors
- The opportunity for the public to be able to offer feedback and comment
- The comparatively small size of the proposed Council of Governors
- The proposed geographical make up of the Council of Governors
- Staff supported the proposal for an "opt-out" arrangement for staff membership (including the proposal for Trust volunteers and Carillion Health staff who work at the Trust to be included within the staff constituency)

5.0 Membership Update

As described in the membership a strong and vibrant membership will be key to the success of the Foundation Trust. Our membership as of 4th July stands at **6725** and analysis of the Membership is as below.







5.2.1 Governors

The Council of Governors will consist of 19 governors elected from the following constituencies.

The nomination forms for governors have been received by the Electoral Reform Services. There will be two contested constituency elections; one in Wiltshire and one in Swindon. In Wiltshire 14 members are standing for election for the 3 Governors from Wiltshire. The results of the lection are due on 22nd July 2008.

6. Conclusion

Swindon and Marlborough NHS Trust is en-route to achieving Foundation Trust Status. We believe that the opportunity this gives the Trust to work more closely with the constituents of our catchment area will greatly enhance the service we are able to offer. The feedback from the public consultation was favourable offering further local support for our application.
