IMPLEMENTATION EXECUTIVE 27 AUGUST 2008

STAFFING AND RECRUITMENT

Background

- 1. This report :-
 - 1.1 Updates the Implementation Executive on the appointments made to the post of Corporate and Service Director in the new Council.
 - 1.2 Identifies the work currently being undertaken to develop and populate structures below Corporate and Service Director level.

Corporate and Service Directors

- 2. In accordance with the principles for appointment, agreed by the Implementation Executive all Corporate Directors and most Service Director posts have now been filled. There are two posts (Chief Financial Officer and Director of Human Resources) vacant. Both are in the process of being recruited externally. There is also a vacancy which has arisen for Service Director (Strategy and Commissioning) in the Department for Community Services. This too is in the process of being recruited externally.
- 3. The list of appointments made is attached.
- 4. The effective date of appointment is currently the 1st April, 2009. However, in respect of the Corporate Director (Mark Boden) and those Service Directors (Mandy Bradley, Graham Hogg, Brad Fleet, Mark Smith) recruited from District Councils, the date from which the appointment takes effect remains open to determination. They are spending, and will need to continue to spend, large elements of time over the next six months or so in preparing for their new role.

Development and Population of Structures

- 5. Service Directors are responsible for developing the structures within their service area. This is due to be completed by mid September. To assist them Service Directors have been issued with written guidelines agreed by the Joint Implementation Team (JIT) and are to have a briefing on this in the near future. Proposed structures will be vetted to ensure that they meet those guidelines.
- 6. Posts within structures will be filled by the application of an appointments procedure. This is currently being negotiated with the Trade Unions. Given the complexities of employment law in this area the advice of Leading Counsel is also being sought before final joint agreement is reached.
- 7. It is anticipated that :-
 - 7.1 The application of the appointments procedure to posts in the new structure will begin as soon as structures have been approved in mid September.

- 7.2 Appointments will be made as quickly as is possible and in accordance with the procedure. This will enable staff to be informed of their position as at 1st April, 2009 as soon as possible. However, this process is likely to take several months.
- 8. In any event, some structures will not be reviewed and revised until some time after vesting day. Many staff will remain doing exactly the same job in exactly the same place beyond April 2009.

New Appointments

- 9. A few months ago the JIT agreed that in the interests of long term harmonisation, there would come a point at which appointments to permanent vacancies should not be made to the employment of the District Council but to the County Council.
- 10. It is proposed that this apply from 1st October, i.e. about the same time as the appointments procedure in respect of existing staff begins to be applied.
- 11. The process would be that the vacancy be:-
 - 11.1 Recruited and managed by the appropriate service manager with whatever authority.
 - 11.2 Appointed and contractually subject to the County Council pay, terms and other conditions.
