	Caroline Brailey summarised the issues process and how issues sent in through this process would be addressed. She explained that not all issues are appropriate for the Area Board, but it is still useful for Councillors to be aware of them. A number of highways issues had been received, many will be addressed through the presentations and others will be followed up through direct contact with officers. There was potential for action on the issues of pedestrian access to Pewsey Station and a zebra	

	crossing/traffic calming on Swan Road via a request for Local Transport Plan Funding for feasibility work. 	Peter Dunford brought attention to the Performance Reward Grant Scheme. £5.4 million was earned by Wiltshire from the Government for performance against targets agreed in a	

	£2.8 million was available over the next 2-3 years for Area Boards to bid for in order to do good work. The first tranche of £250,000 was available from October 2009 and thereafter a tranche of funding would be released every quarter. Community bids should meet local needs, address priorities in the Local Area Agreement and help with difficulties related to the recession. They should be one off projects and a mixture of capital and revenue.
