MINUTES of a MEETING of the REGULATORY COMMITTEE held at COUNTY HALL, TROWBRIDGE on WEDNESDAY 15 DECEMBER 2004.

80. **Apologies** An apology for absence was received from Mr WS Braid.

81. **Minutes of Previous Meeting**

Resolved: To confirm and sign the minutes of the Committee meeting held on 10 November 2004.

82. **Petition - Maiden Bradley: Through Traffic on Road B3092** At the beginning of this item, Mr D Hines, a resident of Maiden Bradley, made a statement in support of the petition, to which the Chairman responded.

On considering a report by the Director of Environmental Services,

Resolved:

(1) *To note that a study had been commissioned to further investigate freight movements and speeds in the local area and that a report would be presented to a future meeting of the Environment Advisory Panel setting out the findings and recommendations of the study.*

(2) *To advise the petitioners accordingly.*

83. **Dilton Marsh: High Street – Traffic Calming Update** At the beginning of this item, Mr S Braithwaite, a resident of Dilton Marsh, made a statement setting out his concerns about the traffic calming measures, to which the Chairman responded.

On considering a report by the Director of Environmental Services,

Resolved:

- (1) *To agree that the traffic calming features in High Street, Dilton Marsh remain as constructed, with the exception of an alteration to the build-out outside No. 33 High Street to provide a pair of speed cushions, together with painted 'slow' markings on the westbound approach lane to the village.*
- (2) *To advise the petitioners and the objector accordingly.*

84. **Amesbury: Proposed Diversion of Byway 1 and Bridleway 29** On considering a report by the Director of Environmental Services,

Resolved: Subject to obtaining the consent of Amesbury Town Council and Salisbury District Council, to make an application to the Magistrates' Court under the provisions of Section 116 of the Highways Act 1980, to divert the following lengths of track, as shown on the plan at Appendix B attached to the Director's report:-

- (1) *That section of Bridleway 29 Amesbury, A-B to a new line A-C, so that it lies within the new estate road corridor,*
- (2) *Byway 1 Amesbury (part), to the west around scheduled ancient monument No. 12200, (between points D and E), and*
- (3) *Byway 1 Amesbury (part) from its access point on the A303 Trunk Road, leading south for approximately 300 metres, (between points F and G), to a new access point on the Allington Track (between points F and H).*

On considering a report by the Director of Corporate & Library Services,

Resolved: To defer consideration of the application to register land at Pine Walk/Oak Drive, North Bradley as a Village Green in order to allow more time for evidence of use to be obtained.
