MINUTES of a MEETING of the REGULATORY COMMITTEE held at COUNTY HALL, TROWBRIDGE on WEDNESDAY 2 FEBRUARY 2005.

1. **Minutes of Previous Meeting** At the beginning of this item, the following members of the public made statements about Minute No. 85, to which the Chairman responded:-

<u>*Resolved*</u>: To confirm and sign the minutes of the Committee meeting held on 15 December 2004, subject to the following alteration:-

<u>Minute No. 85 – Commons Registration Act 1965 (as amended) – Application</u> for the Registration of a Town Green: Land at Penleigh Park, Westbury Resolution to read as follows:-

"To register the land at Penleigh Park Westbury as a Town Green but not to include land that is in the ownership of Persimmon Homes and to defer consideration of any application which may relate to land owned by Persimmon Homes in order to have a clearer understanding of the basis of Persimmon's objection."

- 2. **Members' Interests** The following members declared interests as follows:-
 - Mr CEG Read declared a personal interest in agenda item no. 17, Commons Registration Act 1965 (as amended) – Application for the

Registration of a Town or Village Green: Land to the North of Old Hollow, Mere, known as Peasehill (see Minute No. 12 below) as he had signed a petition opposing a planning application in respect of the land known as Peasehill. He would leave the meeting for consideration of this item.

- Mrs P Rugg declared a personal interest in agenda item no. 22, Appeal for Free Transport from Melksham to Devizes School (see Minute No. 16 below) as she was a Governor of Devizes School. She would however take part in the discussion and vote.
- Mr CEG Read declared a personal interest in agenda item no. 24, Appeal for Free Transport from Tisbury to Gillingham School (see Minute No. 18 below) as he was a Governor of Gillingham School. He would however take part in the discussion and vote.
- 3. **Department for Transport Consultation Document Setting Local Speed Limits** On considering a report by the Director of Environmental Services,

Resolved:

- (1) To note the response to the questionnaire on the draft revised guidance, as set out at Appendix 1 of the Director's report.
- (2) To request the officers, on receipt of the finalised guidance on the setting of local speed limits from the Department of Transport, to prepare and present to a future meeting of this Committee, a policy for the introduction of speed restrictions in Wiltshire.

4. Speed Limits - Consideration of Objections

- (a) Village School 30 mph Speed Limits
- (b) A4 Local Safety Scheme Speed Limits
- (c) A365 Development Related Order

On considering a report by the Director of Environmental Services and on hearing the views of local members,

Resolved:

- (1) To re-advertise the village speed limit at Woodford to incorporate the southern extension to the 30mph restriction in Middle Woodford, as set out in Appendix A2 to the Director's report.
- (2) To implement as advertised speed restrictions at the following sites, as set out in the Director's report:-

- (i) Semley Village School
- (ii) Local Safety Scheme Sites on the following roads:-
 - Road A4 west of Box
 - Road A4 Box to Corsham
 - Roads A4/A342 Chippenham to Derry Hill
- (iii) Development related site on Road A365 Melksham Without (Bowerhill)
- (3) To inform the correspondents accordingly.
- 5. **Calne: William Street & Luckett Way Traffic Regulation Order** On considering a report by the Director of Environmental Services and on hearing the views of Mrs NS Bryant, the local member,

Resolved:

- (1) To make permanent the Experimental Order on William Street and Luckett Way, Calne.
- (2) To inform the objectors to the Experimental Order accordingly.
- (3) To monitor the situation over an extended period to gauge the use of William Street and Luckett Way by non-access lorry traffic.
- 6. **Corsham: Priory Street Objections to Traffic Calming Measures** On considering a report by the Director of Environmental Services and a statement submitted by Mr D Curry, a local resident, and on hearing the views of the local members,

<u>Resolved</u>: To return the scheme to the officers and to request that they re-examine the proposals, as it is considered that the installation of speed humps as proposed is totally inappropriate especially in the conservation area, is detrimental to the overall street scene and is unnecessary.

7. Westbury Leigh: Black Horse Lane – Objections to a Proposed Prohibition of Driving Order At the beginning of this item, Mr F Morland, a resident of Chapmanslade, made a statement objecting to the proposal, to which the Chairman responded.

Resolved:

- (1) To implement the Prohibition of Driving Order on Black Horse Lane, Westbury Leigh when the new road to junction 12 is available for public use.
- (2) To inform the objectors accordingly.

(K.50834) On considering a report by the Director of Environmental Services and a statement submitted by Mr MJ & Mrs L Ellis, local residents,

<u>*Resolved*</u>: To grant planning submission, subject to the conditions set out in the Director's report.

9. Salisbury: Retention of a Single Mobile Classroom with Toilets at Wyndham Park Infants School (S.04.2432.CP) On considering a report by the Director of Environmental Services,

<u>*Resolved:*</u> To grant planning submission, subject to the conditions set out in the Director's report.

10. **Mere: Proposed Diversion of Footpath 53 (Part), Maypole Field** At the beginning of this item, Mr LR Stanton, Mrs M White and Ms A Stevens, local residents, made statements objecting to the application and Mrs IR MacCallum, the applicant, made a statement in support of the application, to which the Chairman responded.

On considering a report by the Director of Environmental Services and letters received from Mr R Finan and Dr D Longbourne, Hon. Curator of the Mere Museum,

<u>Resolved</u>: To make a Public Path Diversion Order, in accordance with Section 119 of the Highways Act 1980, to divert that part of Footpath 53 Mere as it passes through Maypole Field, to the field edge as shown on the plan attached at Appendix B to the Director's report, and, if no objections are received, to confirm the Order as an unopposed Order.

11. Whiteparish: Proposed Diversion of Footpath 4 (Part) On considering a report by the Director of Environmental Services,

<u>Resolved</u>: To refer the Public Path Diversion Order in respect of Footpath 4 (Part), Whiteparish to the Secretary of State for decision, with a recommendation that the Order be confirmed on the grounds that the development cannot continue without the diversion of the footpath and, in the opinion of the officers, a suitable alternative route is provided for the benefit of the public. 12.
