## STATUTORY DECLARATION

**I JOHN BARRINGTON PARFITT** of Trinity Cottage Zeals Warminster Wiltshire BA12 6ND **DO SOLEMNLY AND SINCERELY DECLARE** as follows:-

1. This Declaration refers to land adjacent to Old Hollow Mere Wiltshire recently the subject of an application by Adrienne Howell to have the land registered as a Village Green
2. The plan now produced and shown to me marked JP1 ("the Plan") shows the extent of the land covered in the application ("the Land")
3. I have an Option to purchase the Land from the owner Mr. P. Burfitt of 1 Old Hollow Mere Wiltshire
4. My business has recently obtained planning permission to develop the Land
5. On the 17<sup>th</sup> August 2004 with Mr. Burfitt's permission. I had a barbed wire fence erected along side the bridleway between the points A – B on the Plan so as to emphasise that the Land was private property and the public had no right of access
6. On the 8<sup>th</sup> March 2005 Mr. Burfitt and I placed signs on the Land marked on the Plan as points S1, S2, S3 and a 4<sup>th</sup> sign was placed at a potential access point S4 on adjacent land also owned by Mr. Burfitt
7. On the 17<sup>th</sup> March 2005 a further sign was placed by me on the Land at the point marked S5 on the Plan
8. These five signs all show the same wording "Private property no access except with the express consent of the owner Mr. P. Burfitt No. 1 Old Hollow Mere"
9. At 2.00 pm on the 17<sup>th</sup> March 2005 the signs were all in position and clearly visible
10. The photographs now produced and shown to me marked JP2 show the signs in position on the Land

This is the plan marked "JP1" referred to in the Statutory Declaration of John Barrington Parfitt made before me this 17th day of March 2005.



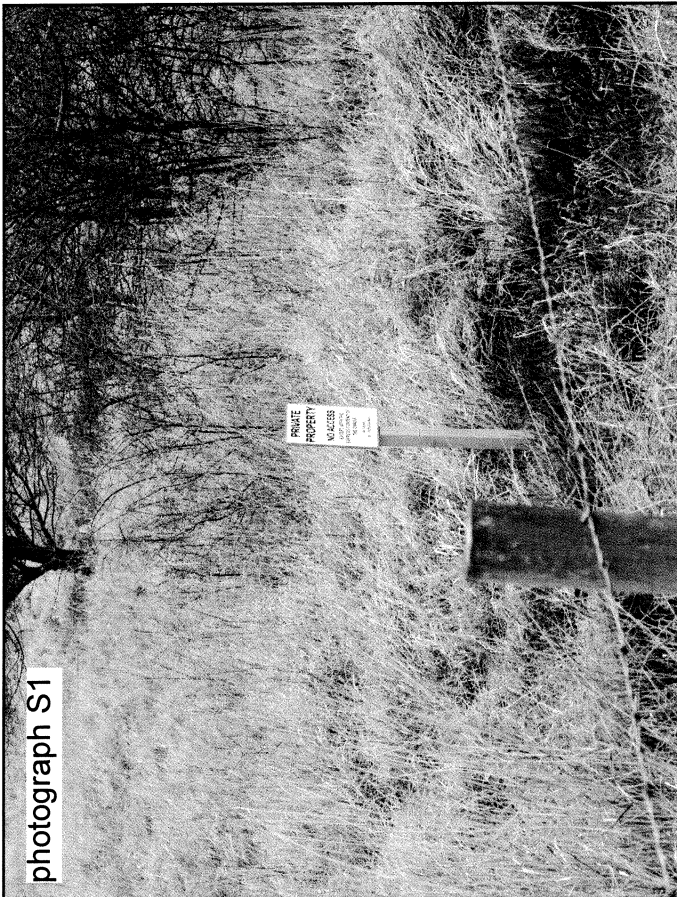

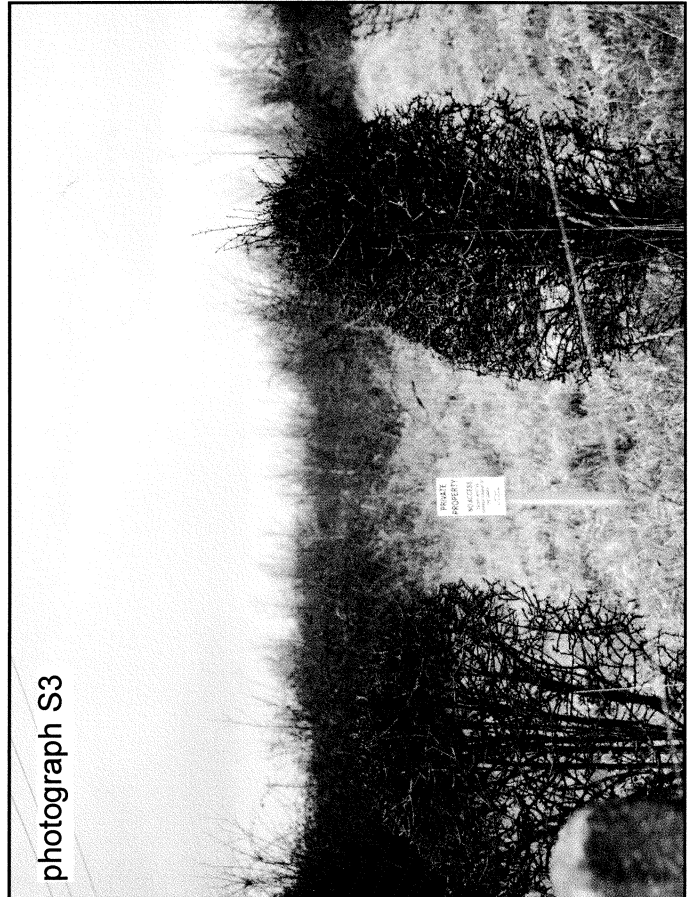


