BANKS	2000 - 2002	Locked when cows in field.	Used several times a week.
BARFORD	1991 - 2002	Middle gate has sign saying no footpath, chained.	Used once a month. Did not always stay to same route.
BARFORD, P	1989 - 2002	Chained.	Weekly with dogs and the Hunt. Route is visible.
BERESFORD, C	1978 - 2002	Gates locked sometimes.	Not all the same route as the claim. Use varies, route varied. Private signs up October 2002.
BERESFORD, F	1978 - 2002	Lock recently.	Used up to twice a week. Not all the same route as the claim. Use varies, route varied. Private signs up October 2002.
BERRY, D	1990 - 2002	Sometimes chained.	Used once a week in the summer for visiting. Saw others using it.
BERRY, S	1955 - 2002	Sometimes chained.	Used for dog walking 15 times a year. Visible path.
BOULTON	1967 - 2002	Locked if cattle in field.	Altered form – route extended to include southern section used on a daily basis and observed others doing so.
BOWMAN	1995 - 2003	Gates only locked in October 02.	Shown the path by Arthur Neale who had used it for decades. Used it daily and observed others doing so. Owner and leasee were aware of use and were friendly.
BRERETON, E	1978 – 2001	Not locked.	Walked it 4-5 times a year with family.
BRERETON, W	1978 – 2001	Not locked.	Used path once or twice a year. Seen other walkers.
CARR-JONES	1979 - 2001	Gate locked when cattle in field.	Walking one day a week, observed other occasional walker. Owner must have seen people walking the route. Did not walk from F-C.
CARR-JONES	1979 - 2003	Not locked.	Used twice a month.
CLARE	1989 - 2002	Not locked.	Lives in Wales. Walked path with god-children, was daily now monthly.
FLEMING	July 2002 - present	Gates locked October 2002	Dog walking 3 times a week.

FOXALL	1998 - 2003	Gates locked October 2002	Used for daily dog walking. Route used daily and owner must be aware of this.
HARRIS, K	1987 – 1997	Gates not locked.	Daily dog walking, used by people frequently.
HARRIS	1992 – 1998	Gates usually open.	Appeared to be well used path. Dog walking route infrequent.
HART, S	2000 – 2003	Middle gate locked.	Amended form, used twice a week. Leaseholder gave her permission.
HART, M	2000 – 2003	Middle gate locked.	Used for dog walking. Amended form. Given permission to walk it by leaseholder.
HEWITT	1970 – 2003	Chained occasionally if cattle about.	Walked path daily for 15 years, latterly once a week. Other people used it. Previous owner was aware it was used.
LAIDLAW, J	1982 - 2002	Occasionally unlocked.	Uses path less than 6 times a year. Seen others using it.
LAIDLAW, M	1982 – 2003	Gates locked since 2002	Did not walk F-C.
LANGDOWN, V	1975 – 2003	Middle gate sometimes chained.	Walks it 6-12 times a year but her children use it much more.
LANGDOWN, A	1988 - 2002		Route to McMillan Way not shown. Use twice a month.
LUKE	1991 - 2003	1 gate periodically locked.	Uses path at least 12 times a year.
LUKE, Susan	1991 - 2003	1 gate periodically locked.	Uses path at least 12 times a year.
KINGTON	1956 - 1993		Used it since childhood, 6-14 times a year to visit friends.
KINGTON, J	1970 - 2002		Has used the path since childhood, dog walking 15 times a year. Route varied. Other people walked it.
KINGTON, N	1974 - 2001	Gates usually open.	Infrequently used.
KINGTON, T	1970 - 2002	Chained to keep in cattle.	Walks it frequently.
KINGTON H	1958 - 2003	Chained to keep in cattle.	Used the field at least a dozen times a year. Sign up in October 2002.
KLUKOWSKI, Z	1972 - 2003	Chained to keep in cattle.	Used 6 times or more a year for dog walking. Sign up in October 2002. Lots of people use it.

KLUKOWSKI, T	1967 - 2002	Chained to keep in cattle.	Used 6-30 times a year for recreation, short cut and dog walking. Used by other walkers.
MACKNEY	1997 - 2002		Used 3 times a year. Well worn path.
MACKNEY, R	1997 - 2002		Used 3 times a year.
MARSHALL	1980 - 2003	Gates only locked recently.	Has seen others walking the path. Used it 10 times a year. Has not used E-C.
MARSHALL, Rosalie	1975 - 2003	Gates only locked recently.	Walked it once a month and often saw other walkers using it but not E-C.
McCRAITH	1999 - 2003	Some gates locked if livestock in the field.	Clearly defined worn path. Notices went up in winter 2002. Uses path twice a week.
NEALE, C	Taken as a child, born 1986 - 2003		Used path once a week.
NEALE, N	Early 1960s - 2003	Until October 2002 gates were not locked.	Taken on footpath as a child by parents and has used it several times a week. Signs put up in 2002, number of people use it.
NEALE, S	1980 - 2003	Gate sometimes chained.	Her future husband introduced her to footpath. Used 1980-90 about 12 times a year. 1990 onwards daily. See other walkers.
NEALE, V	1954 - 2000		Used to visit relations in the village as did her husband at least 20 times a year. The landowner must have been aware of the use.
NEALE, C	Born 1958 - 2003	Middle gate sometimes chained.	First taken with parents. Walked it once a week or more.
NEALE, S	Since childhood born 1979 - 2002	Middle gate sometimes chained.	Used it on family walks, frequency varied. Recent years use 7 times a year. Saw other walkers using the path.
NEALE, L	1997 - 2002	Gates sometimes locked.	Used it 4-6 times a year, visiting relatives. Other people use the path.
PACKER, D	1995 - 2002	Middle gate sometimes chained.	Did not walk D-E-F-C. Dog walking route, to visit friends a couple of times a week. Saw other people using footpath.
PACKER, E	1995 - 2002	Middle gate sometimes chained.	Did not walk D-E-F-C. Use 3-4 times a week in summer, less in winter. Observed many others using footpath.

NAME	PERIOD OF USE	GATES	COMMENTS
PEARCE	1959 - 2002	Middle gate sometimes chained.	Used as a route to visit friends 12 times a year. The path has been used by many people. Parents used it from 1953 and her grandfather used it every day to go to work.
PUGH	1998 - 2002	Gates not locked.	Use 2-3 times a month. Regularly used by walkers.
READ	1994 - 2003	Gates not locked until October 2002	Route to Alderton, pub, shop, etc. Use 2-6 times a month. Saw others using it. Never challenged.
STORY	1994 - 2000	Gates recently locked.	Dog walking route 4 times a week. Recent signs. Sign on gate 6 years ago asking people to shut the gate because of cattle.
STORY, S	1994 - 2000	Gates recently locked.	As above.
SMITH	1998 - 2003	Gates recently locked.	Use path 3-4 times a month and see others doing the same. Well worn path.
SMITH	1998 - 2003		Saw others using path and began to use it himself. Used path to visit his mother in Avon Rise 3-4 times a month. Seen lots of people using footpath since he has lived in Luckington. Worn path.
SYKES	1984 - 1992	Gates not locked.	Runs the shop in the village since 1992 and does not have the opportunity to use it now. Was dog walking route once a week. Regularly used by villagers.
THOMPSON	1998 - 2002		Worn route on the ground. Used it daily as other people.
THOMPSON	1984 - 1988	Gates never locked.	Uses path as a route to work and visiting, used once a week.
THOMPSON	1998 - 2002	Gates sometimes locked when cattle in field.	Worn path, used daily and others use it.
WAITE	1954 - 2002	Gates never locked.	Used path since childhood. Uses about 3 times a year.
WAITE, G	1954 - 2002	Gates never locked.	Began using path as a child and uses it 6 times a year. Avoids using the B4040. Regularly used worn route.
WALKER	1966 - 2003	Gates never locked until November 2002	Used between A-D-B since childhood weekly to go to Brownies now 10-15 times a year to visit friends on the Bristol Road.

NAME	PERIOD OF USE	GATES	COMMENTS
WERRETT	1975 - 1992		Usually uses path between A-D-B. On rare occasions has used all the claimed routes. Used 4 times a year. Many people used footpath.
WESTON	1991 - 2003	Gates now locked.	Walks the path daily. Spoke to Mr. Simkins on many occasions.
WILDING, Mr. & Mrs.	1998 - 2003	Gates occasionally locked.	Walks the path with family and dog 4 times a week. Routes are in constant use and it is exceptionally rare to not see others walking it.
WOOD	1994 - 2003	Gates locked from October 2002	Dog walking route 8-10 times a month. Living by the field sees others using path, walks the dog around the edge, tenant does not mind.
WOOFF	1963 - 2003	Gates sometimes locked for cattle.	Use path to go into the village to the shop once a week. See others walking it.
YORKE	1955 - 2003	Gates padlocked October 2002	Walks it with friends and dogs 20 times a year. Often sees others walking it. Owner was aware of use. Usually uses path between A-D-B, occasionally all the claimed path. Have used path since childhood.
