- 1. **Apologies** An apology for absence was received from Mr C Newbury.
- 2. Minutes of Previous Meeting

Resolved: To confirm and sign the minutes of the Committee meeting held on 19 December 2007.

3. <u>Latton: Inert Aggregate Recycling Facility at Eysey Manor Quarry near Cricklade for Tarmac Ltd (N.07.07017)</u> Consideration was given to a report by the Director of Environmental Services, which recommended that planning permission be granted subject to conditions.

The Committee also considered the views of Mrs HM Dixon, as local member, who drew attention to problems experienced by the local residents regarding heavy volumes of traffic and also the urgent need for resurfacing of Trunk Road A419 which had been promised by the Highways Agency. The officers agreed to write to the Highways Agency regarding the delayed resurfacing works. The Committee then considered how traffic to and from the site would be controlled.

Resolved: To defer consideration of the application pending receipt of a report by the officers in relation to how the suggested 'Transport Plan' would control vehicle movements to the facility and how these would be enforced.

4. Westbury: Construction of Three New Classrooms at Matravers School, Springfield Road for Wiltshire County Council (W.07.09025) At the beginning of the item the Committee received a question and statement from the following members of the public expressing their views in relation to the planning application to which the Chairman responded:

A written statement was also received from Mr Chris Dark – Headteacher, Matravers School.

The Committee then considered the detail of a report by the Director of Environmental Services and after discussion,

<u>Resolved</u>: To grant planning permission, subject to the conditions and reasons set out in the Director's report.

5. Amesbury: Proposed Diversion of Bridleway No 29 Amesbury (Part) At the beginning of the item the Committee received a statement from Mr Graham Eves, representing Amesbury Property Company Ltd, expressing that Company's views in relation to the proposal to which the Chairman responded.

The Committee had before them a report by the Director of Environmental Services, together with a letter from Mr Alan Hill setting out his views and a response on these views by the Officers.

On considering the report and on hearing the views of Mr JC Noeken, the local member.

Resolved: To make and advertise an Order under Section 119 of the Highways Act 1980 to divert that section of Bridleway No 29 Amesbury as shown on the plan attached to the report at appendix 1, from A-B to a new line leading from A-C.
