ARCHER	1955 - 1967 and 2001	Used it daily, dog walking. Saw others using it. Never challenged.
MRS AWMACK	1982 - 2001	Four to five times a week, dog walking. Saw others using it. Never challenged.
MR AWMACK	1982 - 2001	Once or twice a week. Saw others using it. Never challenged.
BABER	1955 - 2001	Walking the dog twice a day. Footpath sign on it. Private Road sign. Never challenged.
BRADFORD	1988 - 2001	Walked it about ten times a year. Frequently used path. Never challenged.
BRUTON	1968 - 2001	Walked it five to seven times a year for pleasure. Other people use it. Has met MOD Police on the route and they never challenged him.
BUSH	1963 - 2001	Signed Public Footpath. Use varied from daily to weekly. Sign MOD, Private Road, Public footpath. Never challenged.
CLAYDON	1966 - 1968 1974 - 2001	Used it once a week, dog walking and riding. MOD footpath sign. Never challenged.
DEANE	1965 - 2001	Walks and runs along it. Dog walkers use it. Never challenged.
DOHERTY	1961 - 2001	First walked her children along it. Used it for dog walking three or four times a week. Other dog walkers use it. Never challenged.
DOIG	1979 - 2001	Exercising the dog daily, sometimes twice a day. Never challenged, heavily used path.
DOOHAN	1965 - 2001	Exercising the dog on a daily basis. Signed as path. Never challenged.
DOOHAN	1952 - 1956 1965 - 2001	Used it for general recreation. Riding, dog walking at least on a daily basis. Signed as path. Never challenged.
FRY	1965 - 2001	Dog walking route. Weekly use. Signed as Footpath. Never challenged.
FULLER	1950 - 1992	Sometimes overgrown. Used it regularly on foot and cycle. Signed as Footpath. Well used path. MOD aware the public use it. Never challenged.
GIBBS	1964 - 2001	Used as part of a cross country run on a monthly basis. Saw others walking it. Never challenged.

Name	Period of Use	Comments
GINGELL	1967 - 2001	Dog walking and recreation six times a week. Saw others horseriding, jogging and bird watching. So many people use it believe owners must know of use.
GIPP	1995 - 2000	Signed as Footpath. Used it for dog walking on a daily basis. Owner must have known public were using it.
HENDERSON	1981 - 2001	Recreational walk after work, used it six times a year between 1981 - 1991. Less now. Never challenged.
PENNEY	1971 - 2001	Walking dogs, horseriding, cycling. MOD Footpath sign. Owner must have been aware of the public using it as everybody used it.
PULLEN	1965 - 2001	Walk it once a month. Never challenged.
OLLIVE	1990 - 2001	Dog walking route and blackberrying. Use once a month. Popular walk for the residents of Neston. Never challenged.
MR OLLIVE	1990 - 2001	Used it mainly for dog walking twice a week. Popular walk. Never challenged.
RASELL	1983 - 1997	Use it for dog walking once or twice a week. Never challenged.
ROGERS	1990 - 2001	Use it about once a week. It is regularly used by people in Neston and the landowners must know this. Never challenged.
MR ROGERS	1968 - 2001	First used it walking Grandmother's dog 30 years ago. Walked the dog on it several times a week. Now walks it less frequently with child. See others walking, cycling and riding.
SLEIGHTHOLME	1967 - 2001	First used it walking the dog. Now use it nine times a week for recreation. See others walking it. So many use it the landowners must know. Never challenged.
TODD	1982 - 2001	Walk or lead a horse along it at least twice a week, never challenged.
TURNER	1950's - 2001	Walk it about 20 times a year with her dog. Never challenged. Walked by many people.
VAUGHAN	1969 - 2001	Use it for daily dog walking. Many people use it and does not know of anyone who has been challenged, so the owner must know it is used.
VITELLI	1994 - 2001	Use it for daily dog walking. Never challenged.
