30 witnesses have regularly used the path, one states this was with permission although this was not permission from the owner of the land and can still be considered to be 'as of right'..

All 30 have used the same route and none report obstructions, gates or notices until January 2007 when the way was first called into question by the erection of fences and the erection and locking of gates across each end of the claimed route.

They all claim to have used it for walking or riding and it has been mainly used for recreational purposes such as family walks, riding for pleasure, dog walking and exercise for health.

22 have used it for walking, 11 have claimed to use the route for horse riding. Three of the witnesses have used the route for both purposes.

Eight witnesses have stated that they have seen others horse riding.

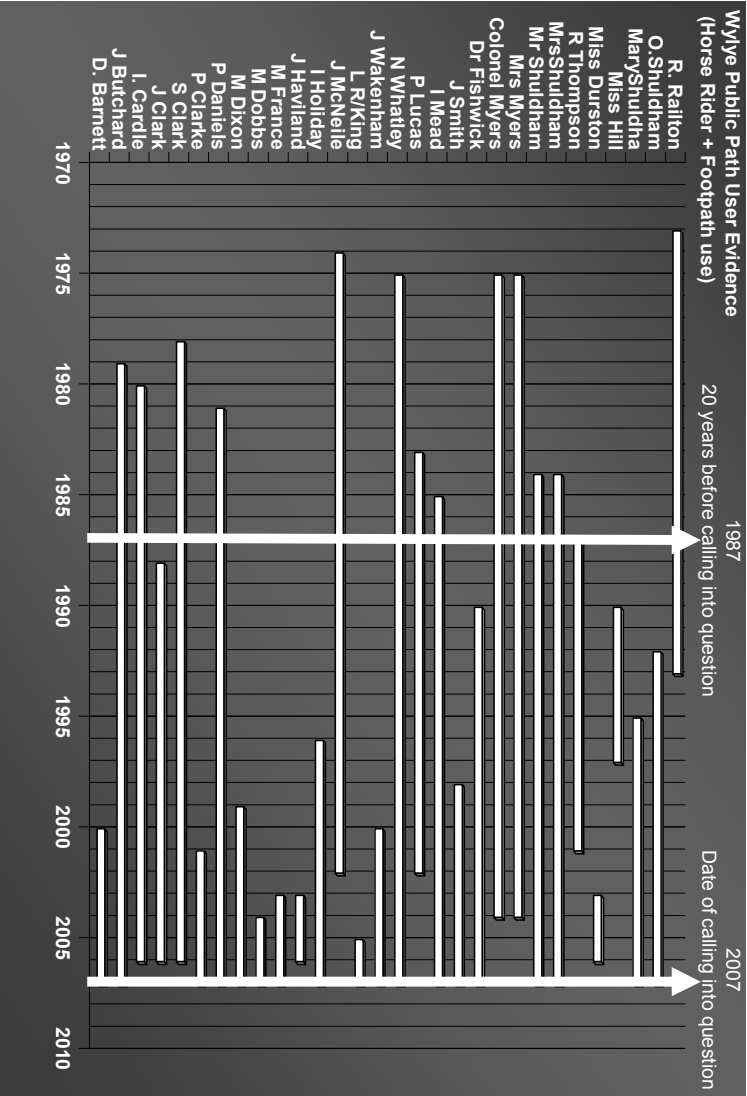
Two of the witnesses claim to have cycled the route.

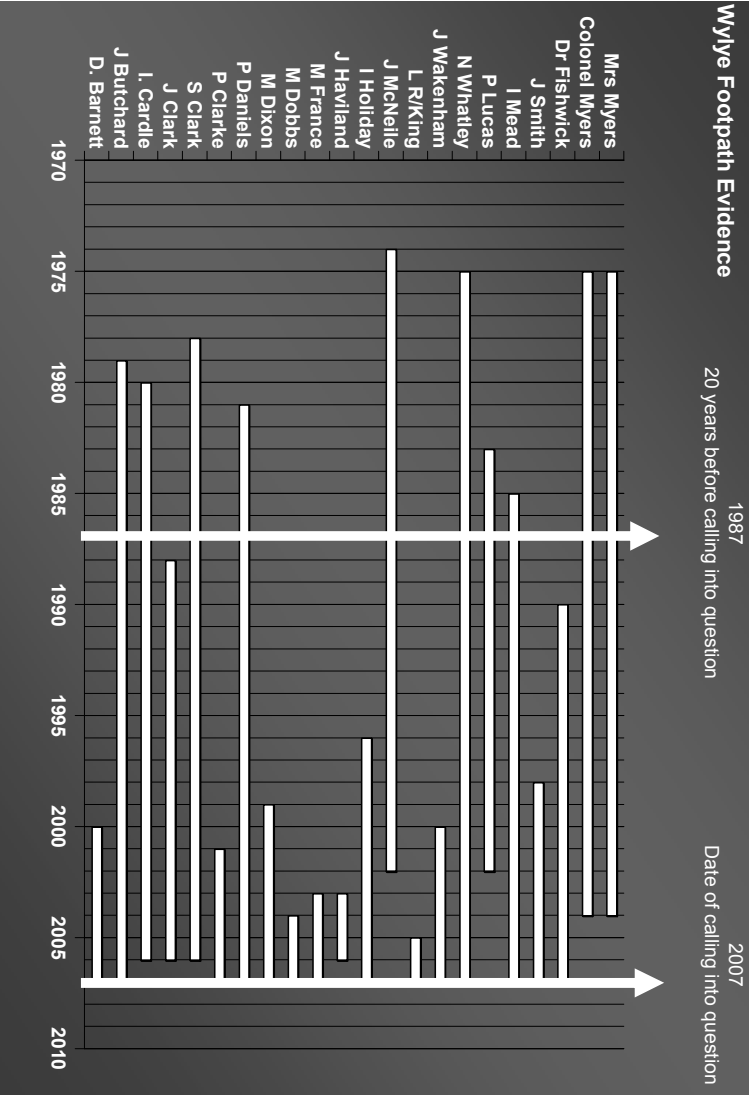
