A question was received concerning CLAG shares and whether it was fair to exclude persons on the periphery of the Calne area from owning shares.

# CA20. Request for Calne Community Area (5) Funding from Calne Leisure Action Group (CLAG)

Consideration was given to Report No. 5 which presented Members of the Calne Area (5) Committee with recommendations relating to an application seeking funding from the 2007/2008 Community Area Award Scheme.

Issues discussed included:

- The recent history of the leisure centre;
- The importance of the centre to the Calne community;
- That the White Horse Leisure Centre was losing a smaller amount of money than the other centres originally earmarked for closure;
- Previous attempts to use the Community Area Awards to help the leisure centres;
- The hard work done by CLAG; and
- That it was now vitally important for people to use the centre.

**Resolved** to agree funding distribution of the Area 5 Community Area Awards budget based upon the agreed criteria for 2007/2008.

Calne Leisure Action Group (CLAG), or other such body set up by the group – Award £75,000 from the capital budget towards the purchase of gym equipment for the White Horse Leisure Centre, conditional on the Executive agreeing to CLAG taking over the running of the centre.
