When this happens games have to be cancelled during Autumn and Winter or even at other times after heavy rain with the consequence that income is not forthcoming from the regular users.								
The Playing Fields Association is self-funded and finances the recreational facilities for villagers and other local users, including maintaining the greens, a tennis court and providing play area. Without a regular source of funds these facilities cannot be provided.								
The project is to dig out and install land drains across the affected area (a total of approximately 172 linear metres).								
All users of the playing field, including cricket club, football club, and village users in general will benefit from the site being drained.
