4. Summary of Afternoon Workshops on Specific Topics

4.1 Land Based/Countryside

- Rural zone
 - Sensible, sympathetic planning
- Greenfield sites
 - Sensible, sympathetic planning
- Recognising need
 - low cost
 - affordable
 - Motivated by Sustainable/shops/workplace
- Overdevelopment
 - Protect rural buffers but still meet local NEED
- Strike balance
 - not to be dictated by Government Policy, should be local policy
- River
 - major asset to county
 - hould be made accessible
 - rural as well as urban
 - Revisit River Green Projects
 - Path from Chippenham to Malmesbury along river for starter

4.2 Education/Culture and Leisure

- Improve Playing Fields
- Include other activities skateboard, archery, basketball etc.
- Connect into cycleways (which need to be improved)
- Wiggly bus availability
 - Remove dangers speed
 - Needs to be in the plan
- Leisure:
 - Multiplex, ten-pin bowling created around Bath Road car park and Bridge Centre
 - Work with partner to create by 2006
 - Look at working closely with schools use their facilities
 - Use of Olympiad etc to provide facilities in the near future
 - Neeld/Town Hall (expensive!!)
 - Villages use Town facilities but no transport so cars (e.g. Abbey School)
- Village Schools
- Satellite Libraries (Cepen Park, Pewsham etc)
- Broadband Improve publicity
- Expand Adult Education including Culture (Jazz, Classical etc)
- Play areas Including Skate parks, BMX areas
 - All councils to co-operate (town, district, county)

 Where – survery of need – access, location, need of population

4.3 Crime

- Limited resources.
- PCSO's (Police support officers) are being increased therefore reduce fear of crime. Visible on streets (from October 04)
- (Combination of additional Police resources and T.C buy in)
- Police to profile Chippenham area to see what additional resources in an ideal world they require. (tasking co-ordinating, allocate PCT's/PCSO's)
- Having someone who has time to build up relationships
- Drinking on streets/drunk
- Underage drinking!
- Leads to Anti Social Behaviour
- Work with other Agencies i.e. Reach out
- Liaise with Police as to when or if an <u>AE2</u> should be introduced and where
- Liaise with WCC Trading Standards selling to under age children.
- Reach out

4.4 Health & Social Care

- NHS Dentist Research on numbers/population
 - Primary Care Trust (PCT) involvement/Health
 - National issue Need is now. Government
- Doctor/Dentist Infrastructure before Planning Permission
 - Policy Consultation
- Large Housing Development shouldn't be built without adequate planning for Social Infrastructure. Medical/Schooling/Transport
- Social Exclusion within our policies already

4.5 Transport

- Resolve access/egress problems at Borough Parade by erecting a 'No Right Turn' sign at exit to car park – those wanting to turn right turn left and go around the roundabout (by June 2005). This is a simple quick win
- What is the requirement for more car parking in Chippenham town centre?
- What is the town centre?
- Where is the real estate?

- We believe that this is not achievable maybe alternatives should be considered e.g. park and ride – even this may not be financially viable, can we afford subsidy
- Rural bus service you need to identify who requires the service, when and why. Buses will need to make profit, they will need convincing of profitability in changing service

4.6 The Economy

- Chippenham Main Post Office
 - Planning block change of use through planning process. NWDC Charles Prescott.
 - Conservation Area wider consultation required? Who community & development department – Julian Kashlan-Brown
 - Central Government (lobbying) re. Withdrawal of post office facilities
- Pewsham Post Office

4.7 Housing & Built Environment

- Social housing/low cost housing
 - 492 units/households on housing needs register Westlea HA
 - Linked furnishing needs
 - NWDC expensive lobby Office of Deputy Prime Minister – South West

5. Summary of Evening Workshops on Specific Topics

5.1 Health

- Lack of NHS dentists national shortage
- Medical provision needs to increase in line with new housing developments that are being built
- Local education on what dental options are available, private dental care, just paying etc.

Crime and Drugs

Keeping young people occupied and away from drugs and crime

5.2 Transport

- Speed limits in villages Grittleton, Castle Coombe, Burton, the Gibb, Stanton St Quintin, Sutton Benger, Yatton Keynall, Langley Burrell, Kington Langley
- Speed with which people enter villages. Speed indicator devices are effective – consider use of a mobile one on a temporary basis
- Transition into the lower speed limits and enforcement of the lower speed limits
- Traffic calming measures (physical)
- Lights at the Zebra crossing on Hungerdown Lane
- 20mph zone around schools

6. Missing or Other Issues

6.1 Afternoon Missing/Other Issues

6.2 Evening Missing/Other Issues

- Dual carriageway in front of the golf club filters to a single lane where the traffic backs up. Could the 2 lanes continue?
 Related to wider infrastructure issues, is there scope to widen the western bypass to a dual carriageway
- No room for an eastern bypass (Kington Langley and Langley Burrell) but speeding traffic through villages at rush hour is a problem
- Concerns over proposals to expand Morrisons
- Action both planned and responsive by local authorities to meet community identified priorities
- Support and advice for voluntary and community groups to enable local solutions to be explored and knowledge gained (funding etc.)
